


Oil prices ended the day down 0.6% at \$44.77 after the market fell significantly off the back of US jobless data.

Reuters noted that prices came under renewed pressure after Reuters reported that some OPEC+ members would need to cut output by an extra 2.31 million barrels per day (bpd) to make up for recent oversupply. Markets also turned sour as the number of new U.S. claims for unemployment benefits rose back above 1 million last week.

The crack opened at -6.00, strengthening to -5.60, before weakening to -5.80. The Cal 20 crack was valued around -7.85.

Stocks in the UAE port have fallen to a four-month low, with the largest falls in jet fuel and gasoil. Total stocks fell 0.8% to 24.034 million bbls, with middle distillates dropping 3.8% to 3.389 million bbls and light distillates falling 0.3% to 6.894 million according to S&P Global. Stocks have dropped some 22% since its record high on June 1 as increasing demand ate away at the huge stockpiles of crude and products


