

Fertilizer Financial Markets Commentary/Curves NOLA FUTURES & SWAPS

TIDEA

NOLA UREA was slightly firmer today in the futures market and stagnat in the physical market as the trade digest the results from the most recent Indian Tender. We continued to see activity in the September physical market trading \$228 (direct trade) for September today, barges were offered \$230 on the follow. In the futures market, we saw Q4 continue to see traction trading at \$225 again this morning and then shortly after at \$227. The futures markets is still showing some backwardation from Aug/Sept to Q4.

DAP

The NOLA DAP futures market continues to see activity for the Aug/Sept/Oct timeframes as we head into the second half of Q3. Today we saw August trade \$323, offered \$325 on the follow and October futures trade \$319 offered \$319 on the follow. In the physical market - barge values seem to be holding be supported by higher terminal prices.

INTERNATIONAL FUTURES

Intl urea prices remained supported today. Further detail out of India confirmed 700kmt of urea accepted into MMTC's purchasing tender, including fob AG offers at \$255/t. The volume secured offers support over the near term, as India will be back to market shortly to secure the additional tonnes they require. On paper, AG and Brazil urea were bid around last done levels for the September contract, but interest in new short positions remains limited given the current market conditions.
