



Same old story in the afternoon: iron ore surged above \$114. Iron ore went up straight from the open. Aug traded at 116.25 right after the open as buyers were vying for offers. Aug then quickly ascended to trade 116.9 and then 117.1. Iron ore made a late push which saw Sep close out the session at session high of 114.0. Spreadewise, Aug/Sep traded at 3.65, Sep/Oct at 3.1 and 3.15, and Aug/Oct at 6.75.
