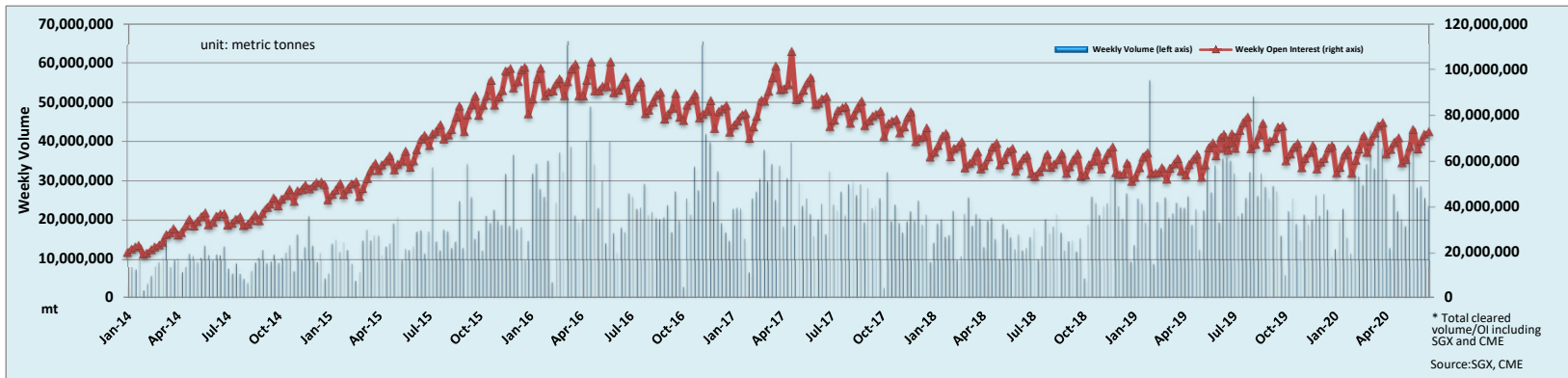
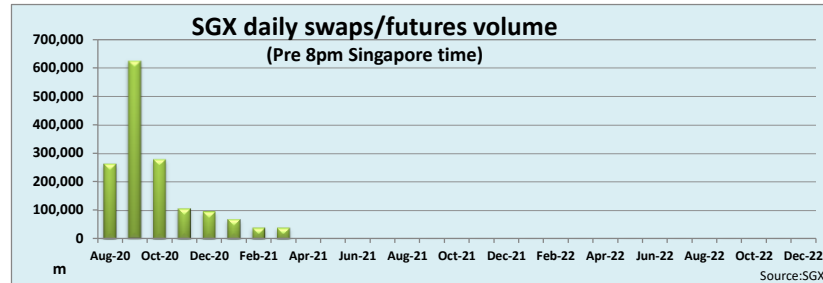
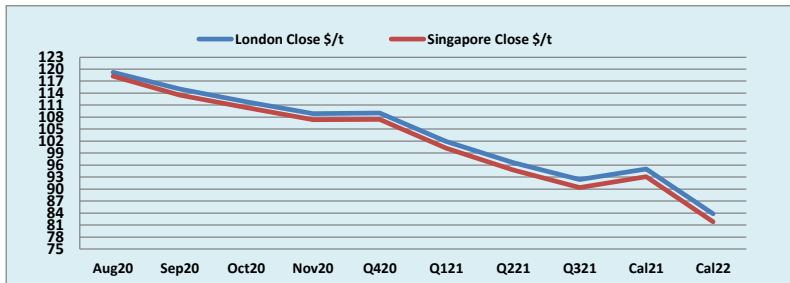

Iron ore extended its gains further this afternoon. September surged above 115.0 this afternoon after news that Baosteel was to increase HRC by 250 yuan in September. Oct also traded as high as 112.15. Spreads-wise, Aug/Sep traded at 4.15 and 4.2, Oct/Jan traded at 7.9 and Sep/Jan at 11.0.
