

The Aug/Sep/Oct fly traded at 0.6 just before the open. Just like the previous day, iron ore was once again under pressure in the afternoon. Iron ore got off to a great start, with Sep drifting above 117.0 upon open but quickly reversed back to pre-open levels. Sep was seen trading as low as 114.65 while Aug was also seen trading down from 120.2 to 119.6. Spreads-wise, Sep/Oct traded at 3.45. Aug/Sep also traded at 4.3.


