



### 07 September 2020

Iron ore extended its gains further in the afternoon. Oct was seen trading as high as 124.35 while Nov also traded 120.45. a late push saw both edged up higher. Spreads-wise, they were largely unchanged. Sep/Oct traded 4.1 in decent size pre-open; then Sep/Oct at 3.45 in decent size, Sep/Dec and 11.5 and Nov/Jan at 6.7.
