


Brent prices ended the day 0.24% down, printing \$41.84 at 15.51 London Time.

Iranian exports have risen sharply in September in the face of US sanctions which has showed the Islamic republic and its economy a small lifeline in its attempt to recover from war. The countries exports have shrunk since 2018 when the Us imposed sanctions on in banking and energy sectors, but exports of crude are now averaging at 1.5 million bpd. (Reuters)


