Oil and Energy Market News

Oil prices end the day up at 1655BST, printing \$41.18 per barrel, up 1.85%. Highs in the day reached \$41.29 with lows of \$40.40 per barrel.

Saudi Aramco are targeting production of 6 million barrels per day within the next three years, with the long awaited 400,000 barrels per day capacity on the red sea due to start production in Q1 of 2021. Earlier in the year Aramco took advantage of the contango market before the oil price crash pre-pandemic. (S&P Global Platts)



The front crack opened at -3.75 and it weakened to -3.95 where it then bounced back up to -3.65 where it remained at the end of the day, closing at -3.55. The Cal21 Crack was valued at -6.40.

The front Sing and Euro weakened throughout the day to print - 30.50 and -9.50. The Barges 0.5% fuel oils continued into backwardation on the front months but the Sing VLSFO went back into contango, with the HSFO also in backwardation at the front.


