
Oil and Energy Market News


Oil prices end the day up at 1700GMT, printing \$50.70 per barrel, up 3.75%. Highs in the day reached \$51.06 with lows of \$48.86 per barrel.

Oil surges this afternoon to highs of \$51+ per barrel as the optimism from the vaccine took hold of the oil market participant thinking and methodology, just a day after the EIA reports a crude build of 15 million barrels. The levels are the highest since the pandemic hit as the vaccine seems to have offered hope of a quicker than expected recovery in demand, with the US potentially rolling out vaccines as early as this weekend.


