



Iron ore futures extended its gains further this afternoon. Sellers were hard to be found during early trading. Feb traded 167.5 when screen was at least 40 cents lower. Mar also traded 40 cents lower at 165.0. Market then caught a bid, with Q1 trading up from 168.0 to 168.5. Feb and Mar traded as high as 168.75 and 166.0. Spreadswise, Jan/Feb traded at 1.8 and Jan/Mar traded at 4.45.
