### **NOLA FUTURES & SWAPS**

### **UREA**

NOLA UREA was a bit lackluster today - values are mainly unchanged from where we saw value at COB yesterday. Very little business was executed today as we end the first month in 2021. January was a record month in terms of CME futures montly volume and we hope to see the trend of increased liquidity continue throughout 2021.

#### **DAP**

NOLA DAP futures continued to firm up today, trading at \$536 for MAR futures. This was up \$11 from last done. Offers were seen at \$540 on the follow for MAR, but markets were quiet overall.

#### **INTERNATIONAL FUTURES**

International paper markets were supported today, ending a week of gains on positive sentiment. Egypt urea paper traded up to 375 for the March contract, in line with the upper end of where physical trading has been heard this week. Buying interest was seen at the same level on the follow, however, offers took a step backwards. AG urea meanwhile, remained supported following yesterday's moves. 371 traded for the March futures contract, up \$1 on yesterday's high.
