



Iron ore futures remained well-supported this afternoon, with Apr ticked up above 170 briefly. Apr drifted lower after re-open before quickly bouncing back, trading at 169.7 and 169.8. Front-month spreads were crushed, with Q3/Q4 trading at 12.65 before leaking a touch as Jun/Q3 was stuck at 8.15/8.40. Mar/Apr did trade 3.7 and then small at 3.75.
