Iron ore futures failed to hold on to \$165 this afternoon as it drifted back to sub-\$164. Apr was seen traded down as low as 163.25 while May also traded down 160.0 to as low as 158.8. Apr/May did leg in at 4.05 when market was around 3.95 while Apr/Jun traded in decent chunk at 7.9.




