In the afternoon, iron ore futures was under pressure from the reopen, with Apr slumped below 160.0 to as low as 159.5 while May drifted down to 154.0. Aggressive Oct sellers saw Oct trading between 134.25 and 134.7, which was at least 50c below value at the time. Then iron ore bounced back strongly, with Apr rallying above 162.0 and May above 156.0. Spreads-wise, May/Aug traded at 11.7. Q3/Q4 was seen trading 11.20.




