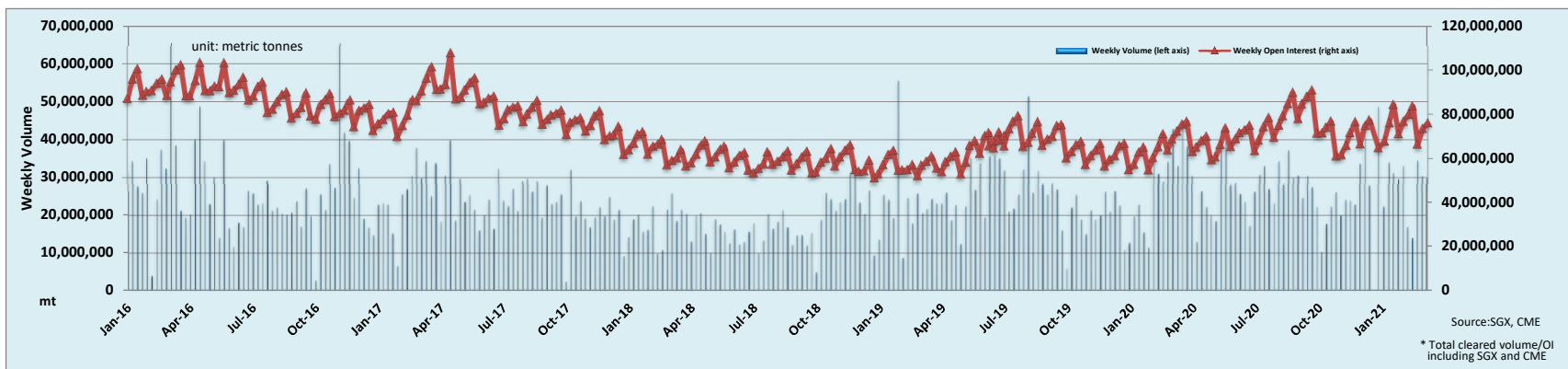
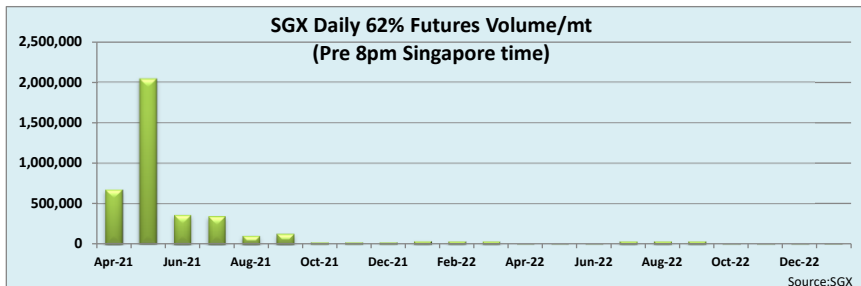
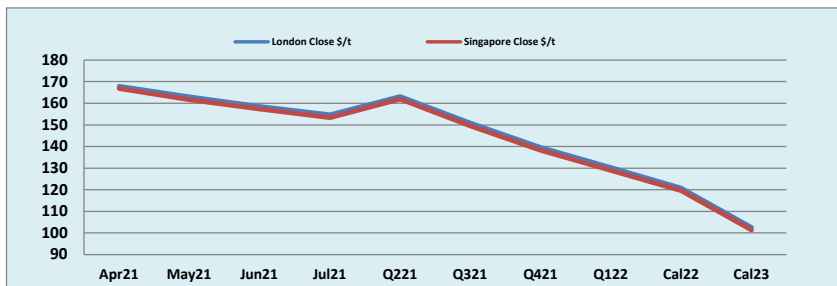
Iron ore futures extended its gains further this afternoon. May was seen trading at 162.0 and 162.2 from the open before edging towards \$163 at the close. Apr also traded 167.5. Meanwhile, Apr/May legged in at 5.25 and then 5.2 before leaking to around 4.85 as the market rallied near the close. May/Jun traded at 4.45 and was heard trading 4.4 in the market.
