Iron ore futures slipped back further in the afternoon. May was under pressure early on, trading as low as 179.4 before rebounding to trade 179.85 and as high as 180.4. Jun also traded up from 175.45 to 175.9 while Jul also traded 171.2. May/Jun legged in small at 4.5 while May/Jul traded at 8.7 in 5.




