


## Oil and Energy Market News

Singapore's robust high-sulphur bunker fuel sales for April reflects continued strong demand for the grade in the world's largest bunkering port, as ready product availability and bunker calls by scrubber-fitted ships keep HSFO consumption supported, despite a growing emphasis on cleaner fuels as decarbonization talks gain spotlight. 
