Iron ore rallied on strongly this afternoon. Jun was seen trading up from 208.2 to 213.1. Meanwhile, Q3 also traded from 198.2 to 198.65 while Q4 also traded 185.25. Spreads, however, were very stable this afternoon except with Jun/Jul widening out to 5.4 while May/Jun narrowed down to 2.5 as market rallied. Q3/Q4 remained at 15.05 and C22/23 were also unchanged.




