Iron ore rebounded to \$207 in the afternoon despite an early blip. Iron ore futures were under pressure early on, with Jul trading down from 205.75 to as low as 203.3. Jul then reversed the losses, trading up to as high as 207.2 before easing off around the close. Jun/Jul traded at 8.0 while Jul/Aug also traded at 6.95 and Aug/Oct at 18.0.
