


## 17 June 2021

Iron ore futures lacked any momentum this afternoon. Jul was seen trading between 210.0 and 211.0 for most afternoon, although it did trade up to 211.4. Aug also traded 203.9 and then 203.6 late in the session. Meanwhile, spreads were largely unchanged; Jul/Q4 did however trade up to 25.85 which looked a very aggressive pay at the time.
