


## **London Iron Ore Market Report**

## 01 July 2021

Iron ore was under pressure in the afternoon, with Aug trading sub-204. It took a while to get going but Aug traded at 203.5 and continued to slide as the session progressed. Aug fell to as low as 202.5 while Sep traded down to 195.75 and Jul at 212.5. Iron ore then rebounded late in the session to around 204.0. Aug/Q4 also traded at 19.0.
