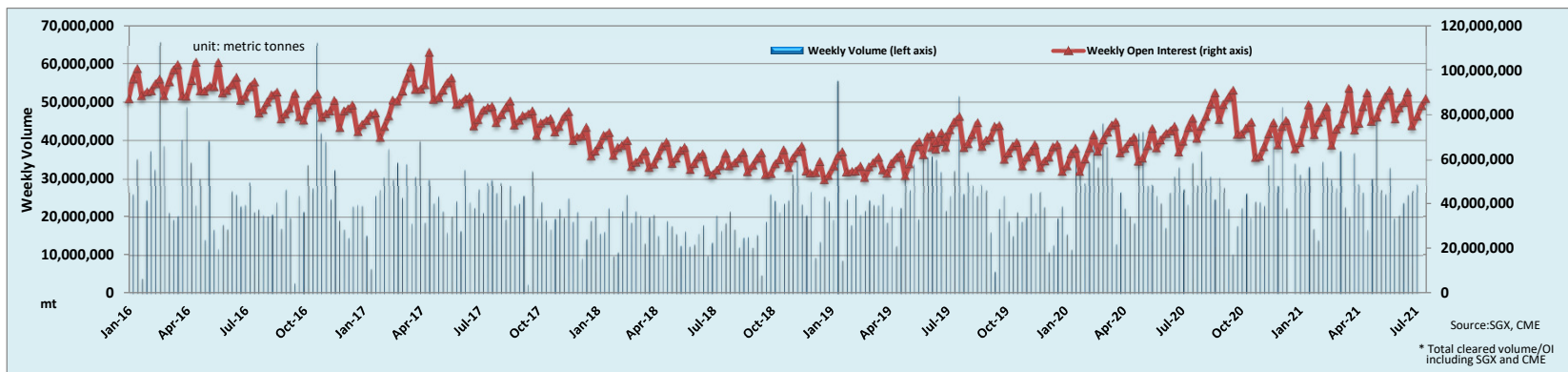
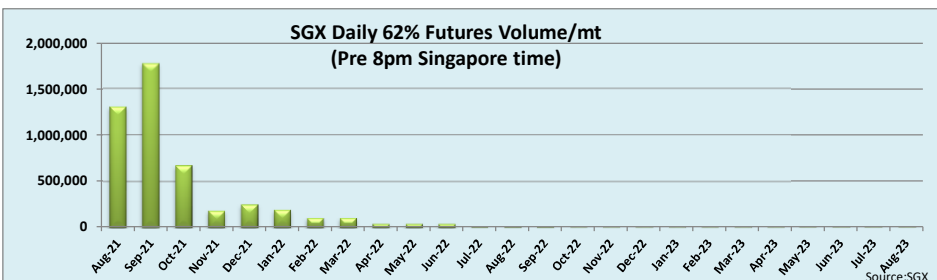
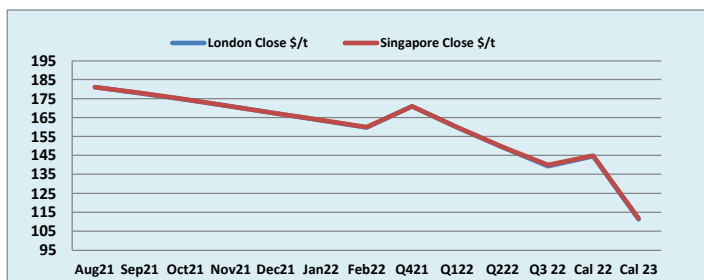
A scrappy afternoon session followed as buyers were mostly absent from the session. Sep was seen trading several clips at 178.0 and 178.15 during the early afternoon before iron ore was under a bit of pressure, with Sep trading down to as low as 177.75. It did tick back up a touch just before the close. In contrast, spreads sellers were mostly missing in action. Spreads were widened out a bit, with Cal 22/23 around 33.3.
