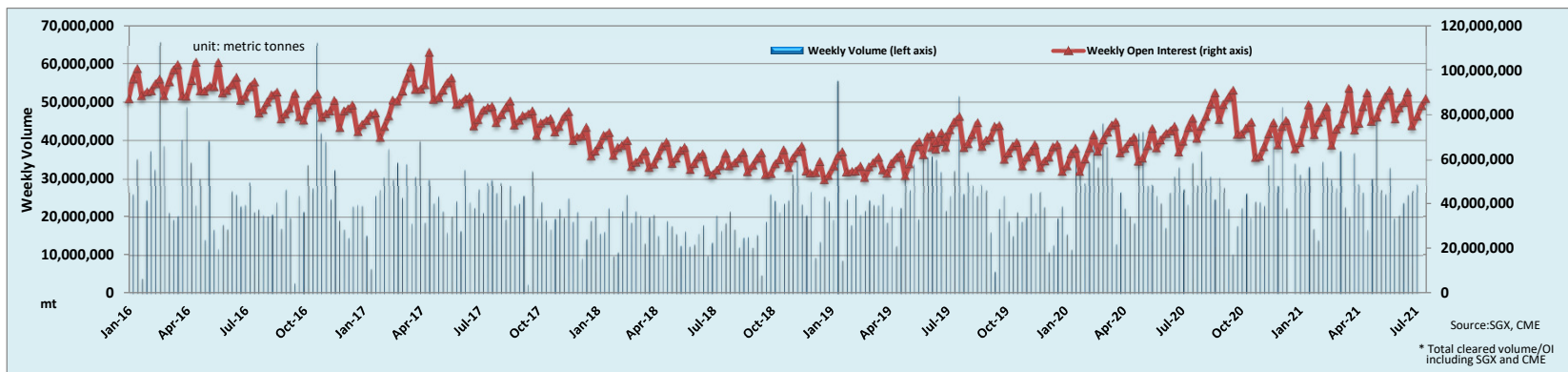
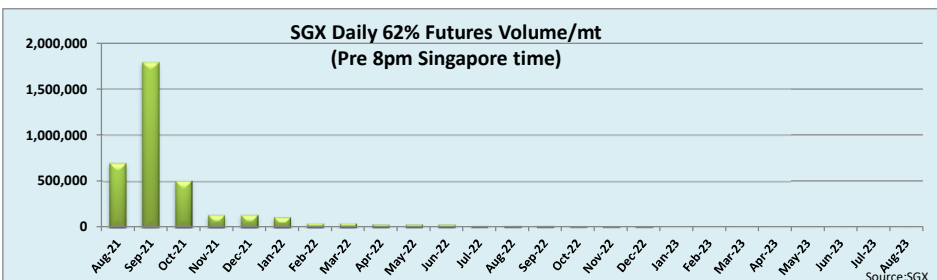
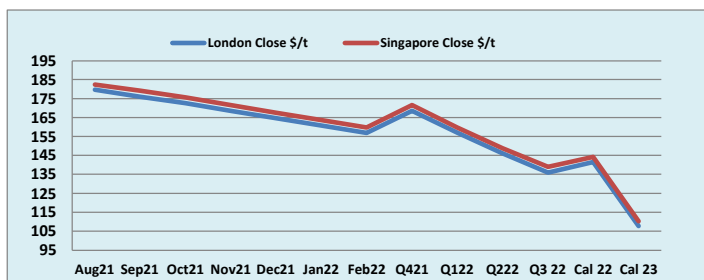
Iron ore futures had a promising start, with Sep held firm above 179. It then came crashing down as a new wave of selloff, with Sep trading down below 176.0. Aug also traded down from 182.8 to sub-180.0. Sep/cal22 traded at 34.7 before narrowing even further.
