

## **London Iron Ore Market Report**



## 13 August 2021

Iron ore advanced in the afternoon as buyers scrambled for offers. Sep was seen trading up to 162.05 and Q4 at 155.4. Q4 was trading between 153.1 and 153.25 early in the session before catching a bid, shooting up to trade 154.0 before eventually trading at 154.4 in decent chunks. Sep also traded up from around 160.0 to 162.05. Frontmonth spreads narrowed a touch, with Sep/Oct legged in at 3.2 and Sep/Q4 legged in at low 6.65 and 6.60.
