NOLA UREA values were flat today on little activity, AUG phys barges traded \$430 in line with last done. In the futures markets, some frames got tight this morning but failed to transact. Sellers don't seem willing to chase it down anymore and buyers seem unwilling to pay up right now until something changes in the international physical market. Overall, the market is thin.

Intl paper was slower today. Physical values were reported lower out of China, but that didn't seem to overly motivate sellers on paper. Nearby Brazil values gave up some of yesterday's gains, but buying interest in paper remains in line, if not firmer than the physical market.
