





Iron ore futures leaked a touch this afternoon. Jan traded 125.0 during the lunch break. Iron ore popped up slightly upon open, with Jan trading up as high as 125.8 but it was not meant to last. Oct traded down to as low as 130.5 while Jan traded down to as low as 124.8. Dec also traded down from 127.0 to 126.3. Spreads were narrower, with 22/23 around 20.40. Q4/Q1 sold down to 6.20.
