




## 14 September 2021

Iron ore sank below \$120 in the afternoon ahead of the Chinese data dump. Market pushed up higher initially with Oct hovering around 122.0. A reversal soon followed as Oct traded down to 119.75 before drifting further down to around 118.6 at the close. Jan traded 117.7 early on while Q3 and Q4-22 traded at 106.15 and 101.9 as market came down.
