Fertilizer Derivatives End of Day Report

NOLA FUTURES & SWAPS

UREA

NOLA Urea markets started off the week with a quiet and inactive tone after last week's flurry of trades. There were no cleared futures trades, and physical barge trading was minimal. November and December barges traded in NOLA this morning at \$665, and offers came in at \$665 on the follow. Later in the afternoon, November physical urea was framed \$665//\$670 December physical urea was reported to have traded at \$675. Chatter was subdued ahead of announcements regarding the recent Indian tender, and many expect India to have to tender again very soon to elevated prices, especially as fieldwork conditions become even more difficult post-river close.

DAP

Late in the day we started to see some bullishness on deferred Q1 NOLA DAP futures trading \$680 for the JAN&FEB contract. The Q1 contract seems to be in contango to where Q4 is valued at.

INTERNATIONAL FUTURES

RCF's tender closed today – receiving offers totalling 1.95mn tonnes from 12 suppliers, and L1 offers of \$714.00 cfr WC & \$665.50 cfr EC. The differential between east/west coast offers, and exactly how RCF will move forward with the tender has caused all sorts of speculation around various scenarios. However, there was no uncertainty in market sentiment on paper as a result – activity clearly more bullish and values significantly higher. On Brazil urea futures, the Oct/Nov spread traded before the tender closed at -8 (\$7-8 narrower than where it was trading earlier in the week). Outright buying interest meanwhile picked up significantly – Nov Brazil traded as high as 761, while bids on AG for the same timeframe ticked into the 700s.
