# Fertilizer Derivatives End of Day Report

## NOLA FUTURES & SWAPS

#### <u>UREA</u>

NOLA urea markets were very quiet today, with only two observed trades between the physical market and cleared futures market. A December barge traded today at \$695 with no significant action on the follow. The Q2 futures strip saw the only real attention for futures today. Offers for Q2 started in the morning at \$715, and gradually ratcheted lower until a trade at \$705 was executed. Continued seller interest on the follow was noted, though buyers that far out on the curve were a bit tougher to come by. The discount of physical barges to the futures market has shrunk considerably as of late.

#### **INTERNATIONAL FUTURES**

Intl paper was offer heavy again today, with selling interest mainly seen in Egypt and Brazil urea futures. Offers have been gradually getting sharper through the week, but not attracting buying interest – values drifting slowly as a result.
