



T+1 saw noticeably less volatility than the morning session, though markets remained skittish and bearish sentiments still dictated trading throughout. The session also saw greater interest in quarterly contracts than in recent days, which have been dominated by trading in the more liquid front months. The post-open jump to a session high of \$112/Mt was short-lived, as futures plunged by nearly \$2 to \$110.25 in sharp order. The market rallied to a degree, almost recovering the session losses before steadily drifting down to session lows of \$109.5. a slight recovery heading into the end of day saw IO62% close at a modest \$0.80 loss on the session to round out a frantic day's trading.
