





A scrappier trading in T+1 session, as many would expect it on the Friday night following the Deepavali. Spreads and futures appeared to diverge somewhat with greater selling interest in the spreads but more bidding interest in outright trading. Quarterly and Cal interest remained strong across the curve, albeit trading in smaller clips, with Cal23/24 seen trading at \$6 in 2.5K/m early on the session. Today's trading ended with Q1, 2 and 3 trading in rapid succession and a modest gain, although still remained \$10 down on the week.
