#### **Market Commentary / Recent Trades**

Singapore iron ore futures saw significantly less volatility during the Asia afternoon trading session compared with the past few days, as futures opened and closed within a dollar, and only once strayed outside of this range. More broadly over the course of T session trading, iron ore recovered somewhat to halt a 5 day run of losses in Singapore trading. Trading was heavily bid again.
