



Iron ore futures rallied consistently throughout T+1, gaining 2.34% over the course of the afternoon. Trading was again concentrated in the front months, though Cal 24 was seen trading in 1Kt/m. Clip sizes were smaller than in the morning session, with the only 100Kt+ being Feb in 120Kt.
