Broad Update:


**BIG DROP.** HRC's underlying index moved -\$65/t on today's print sending more selling pressure into the futures market. Trading thinned from yesterday price action. Oddly, what appeared to be a Q322 v Q422 spread at \$100/t was later determined to be two quarterly strips. The Q422 component traded \$900/t which was \$20/t through our bid level at the time. Money left on the table... Rebar and EHR physical deals remain sparse, but EHR futures saw trading on both Mar22 and Q222 tenors pushing the front end of the curve higher on the day. A couple of export trades were booked yesterday into Turkish mills pushing the HMS index -\$5.5/t on the day. Both cargoes are earmarked for Jan22 delivery. US scrap trading is poised to kick off tomorrow. Front month BUS futures have moved little over the last week. Sentiment points to unchanged to slightly higher index price for Dec21 settlement.
