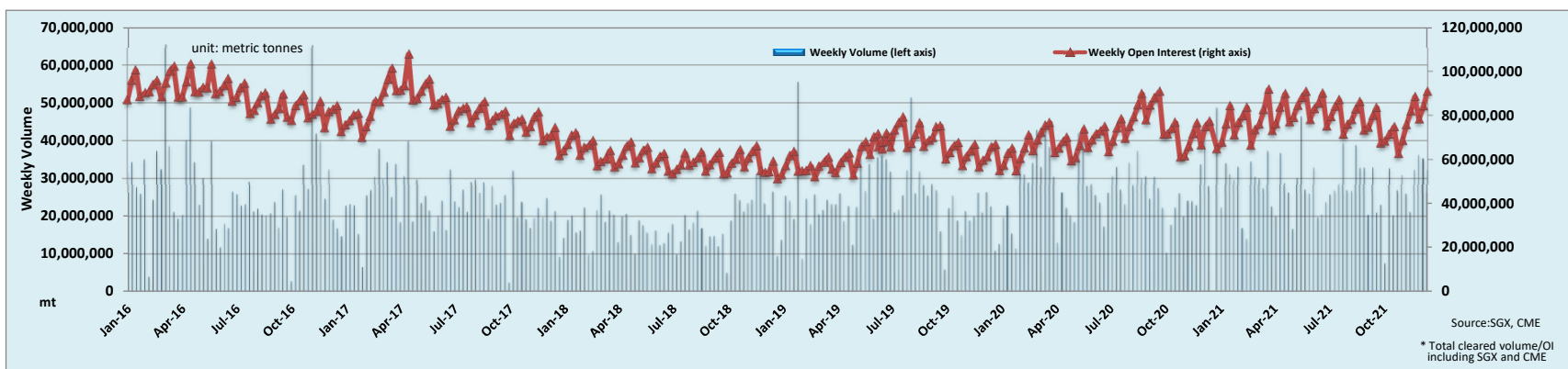
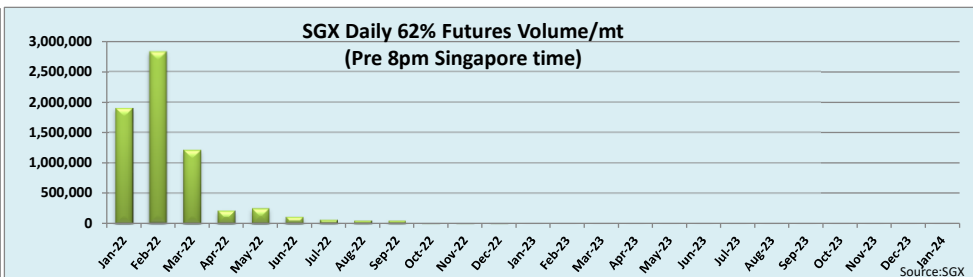
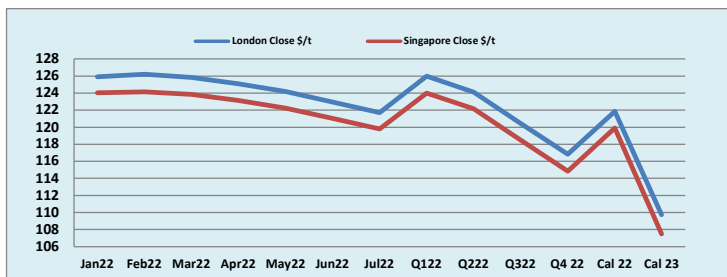
Trading was offer heavy throughout the session. Bulk of interest was again on the front month spreads, though outrights enjoyed more attention than the morning and traded several times in 5-10Kt, particularly Feb. In terms of pricing, front month prices shot up immediately off the open by a dollar and a half, but was then largely stable to close out at 126.2.
