

Feb/Apr was seen trading early on at 1.3 in 200Kt, the largest trade of the T+1 session so far. Jan/Mar found liquidity several times in smaller clips of 5kt, 17Kt, 10Kt and 15Kt. Mar outright was seen trading at 128.25 in 45Kt. Prices were largely stable throughout the session, only once making any decisive move downwards before recovering sharply to close out virtually flat.
