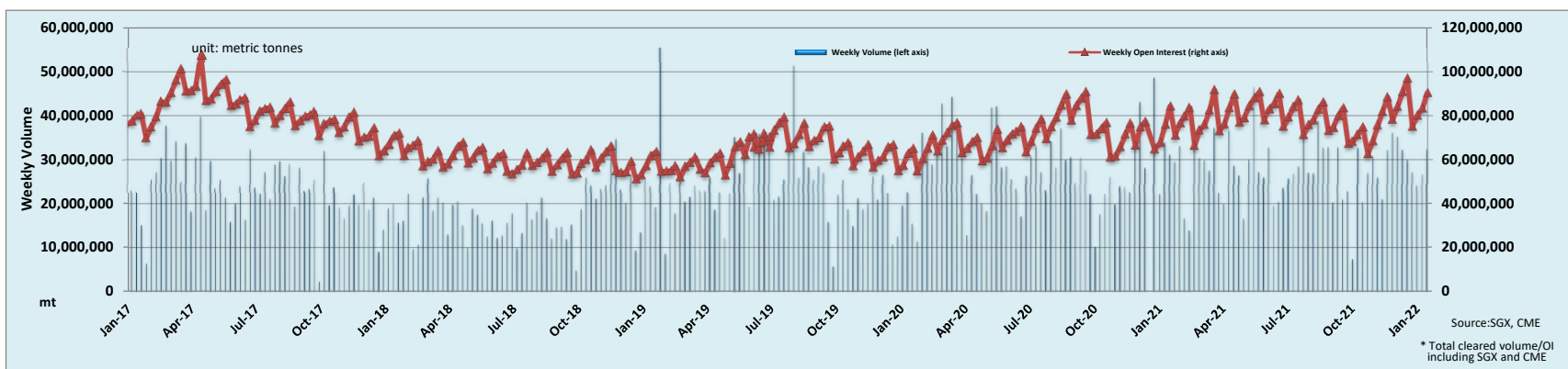
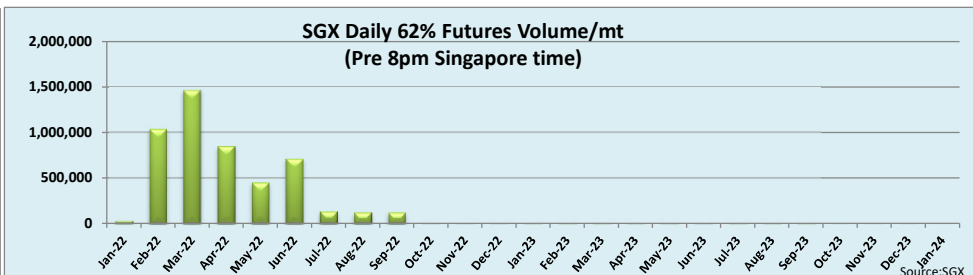
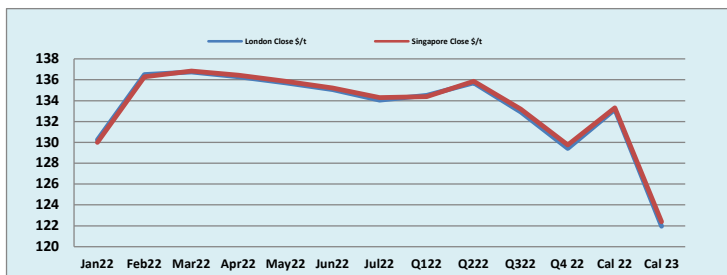
Gaining early on, iron ore futures largely stabilised between 137.4 and 138 flat. Prices came off quite rapidly in the second hour, closing just off the low at 136.5. Outrights were heavily favoured, though the spreads that did trade were in noticeably larger clips.
