#### **Market Commentary / Recent Trades**

Liquidity picked up pretty noticeably in the London morning, with futures ticking up gradually amid bullish production optimism and supply tightness expectations. Since Monday morning, Iron ore has rallied from lows of 135.25 to 144. Bids were again to be found primarily on the outrights and offers on the spreads, though the spreads were slightly more balanced than they have been throughout the Chinese New Year week so far.
