



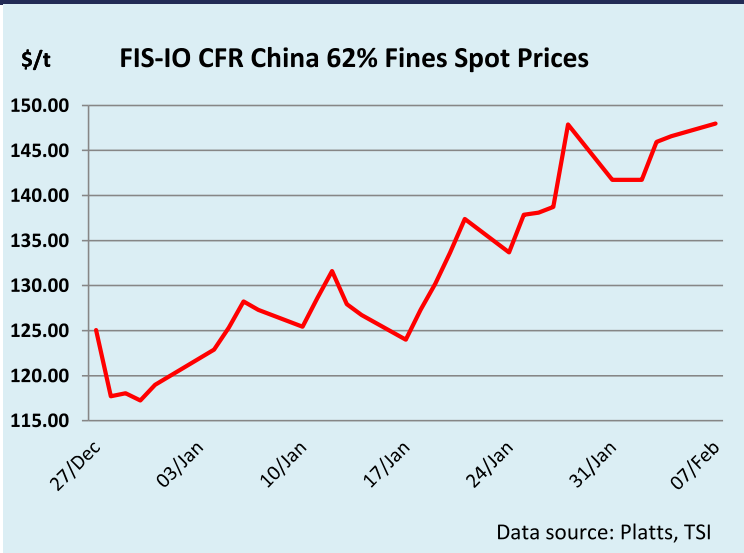

Market Commentary / Recent Trades

Iron ore futures rallied off of the back of supply anxiety emerging from COVID cases in West Australia and heavier than expected rainfalls in Brazil, leading some to expect greater supply tension in combination with bullish demand from China. With last close at \$144.70, iron ore futures rallied to \$147.35 by Singapore midday. Prices rallied initially in the DCE session before coming off a dollar suddenly and closing out at \$146.40. Trading was offer heavy on the spreads, though liquidity was arguably higher on outright.

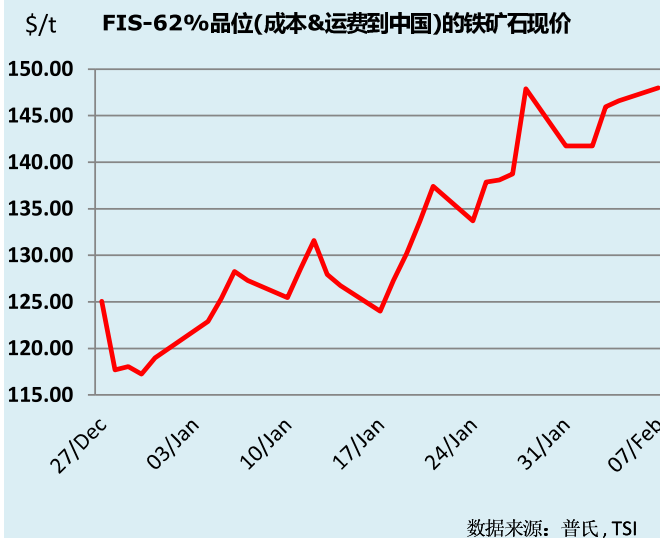

市场评论 / 近期交易

在西澳大利亚新冠肺炎病例引发的供应焦虑和巴西降雨量大于预期的背景下铁矿石期货反弹，市场预计供应紧张加剧以及来自中国的看涨需求。新加坡早盘时段，铁矿铁矿石主力期货从前收盘价\$144.70美元上涨至\$147.35美元。价格最初在大连交易时段上涨，然后急速下跌1美元并收于146.40美元。尽管直接交易的流动性可以说更高，但点差的交易量很大。
