



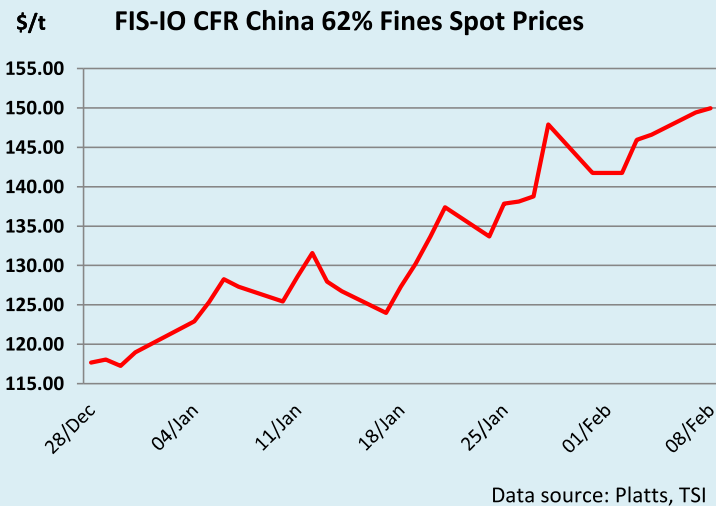

Market Commentary / Recent Trades

A very dramatic morning on iron ore futures which saw a dramatic and immediate sell off in the latter half of the DCE session. Having held largely stable around \$149 throughout the Singapore morning (high \$151, low \$148.7), volatility surged during the session with prices jumping to \$150.5 before tumbling to as low as \$146.5 without warning or apparent cause. Prices steadily recovered though not to pre-crash levels to close out at \$148.25.

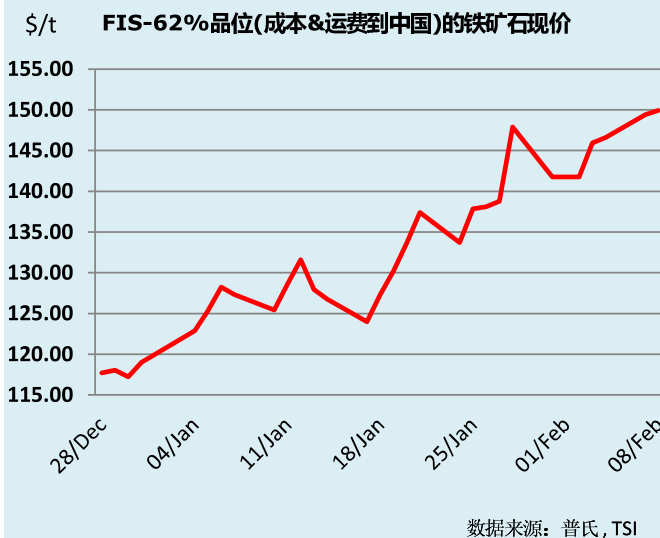

市场评论 / 近期交易

早盘铁矿石期货波动巨大，并在大连后半段交易时间出现大量抛售。整个亚洲早盘基本稳定在149美元左右（高位151美元，低位148.7美元），盘中波动性飙升至150.5美元，随后在没有明显原因的情况下跌至146.5美元的低位。之后价格稳步回升，但未达到崩盘前的水平，收于148.25 美元。
