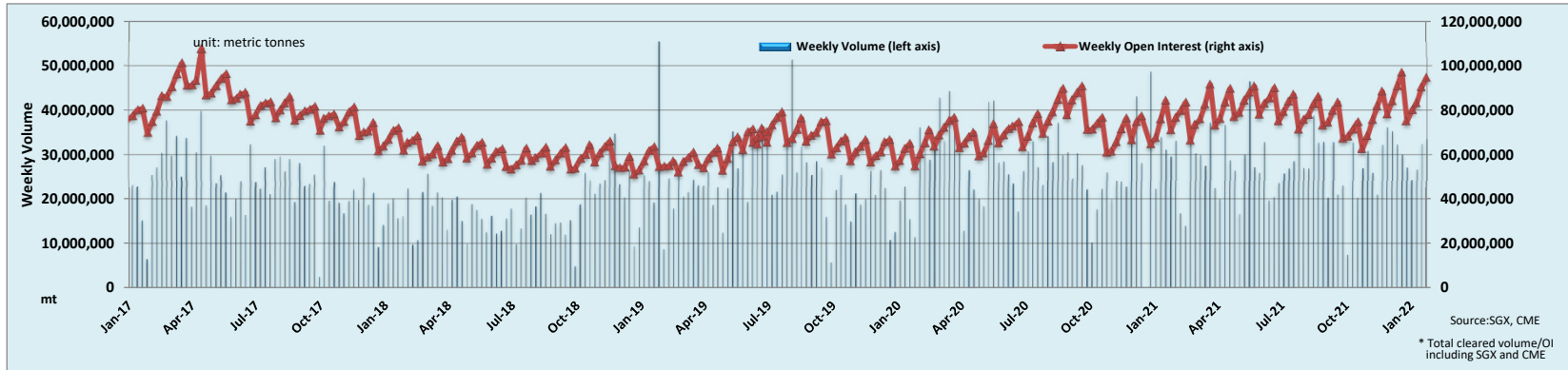
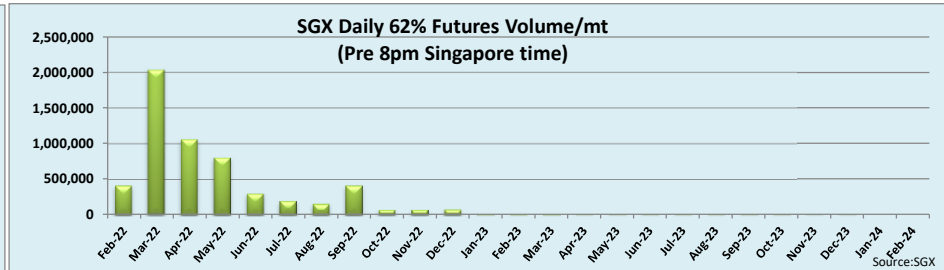
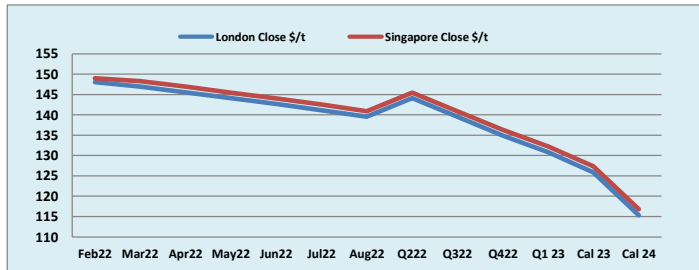
Very choppy session, though less dramatic session on IO in the T+1, with prices never really settling thoughout. IO futures plunged 50 cents initially from the offset. Quarterly spreads again gained more attention than usual, with the Q2/Q3 and Q3/Q4 both finding liquidity. Monthly outrights gained favour over their spread counterparties though Apr/Jul was seen trading in 25Kt clips several times toward the tail end of the session.
