



Pace of trading showed little sign of slowing in the T+1, as markets were largely undecided and failed to find firm sentiment. Front month prices were highly choppy making for high frequency outright trading in 10-20Kt clips across a number of prices. Liquidity was also found in quarterly spreads, with Mar/Q2 seen trading several times in 20/60 and 40x120 clips.
