

Rather subdued trading in the T+1, despite a reasonable sell off around the halfway point of the session. Opening just higher than the \$140 mark, prices largely held firm for the first hour before taking a downward turn. The second hour saw futures prices fall steadily by \$3.5 to close at 136.5. Spreads were bid heavy throughout, though bulk of executed trading was centred on outright.
