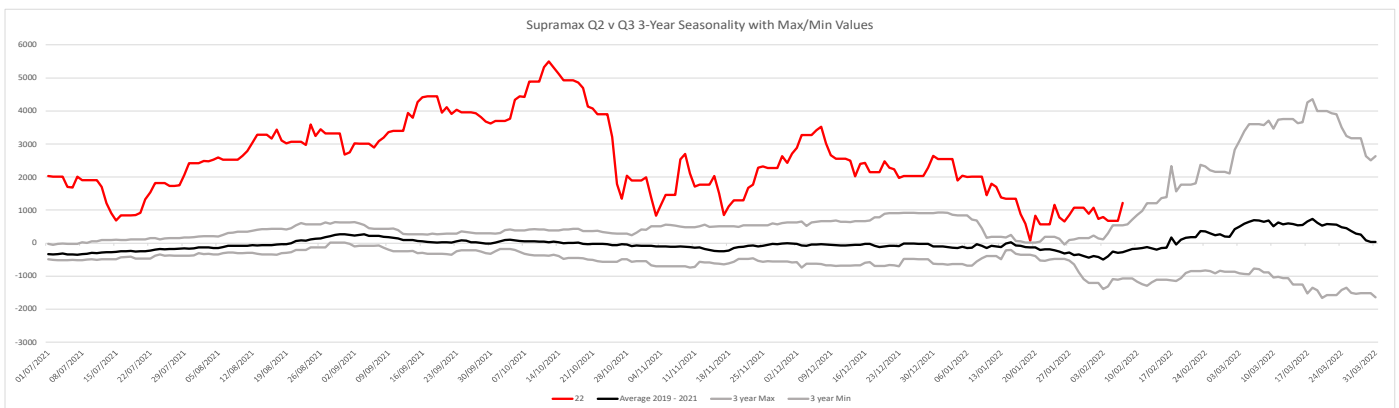


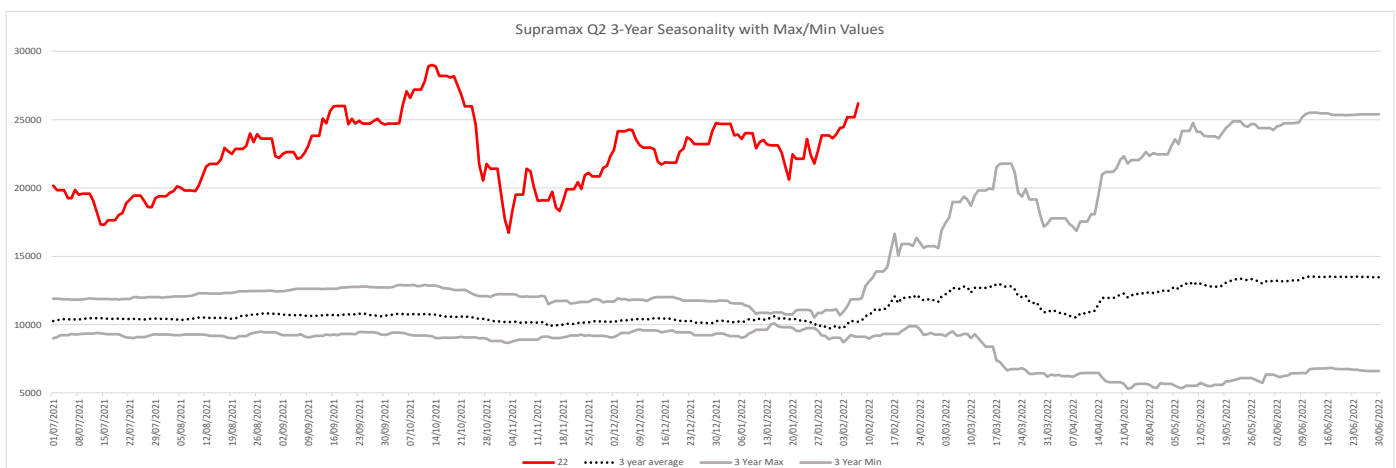

- **Verdict – The Q3-22 futures are overperforming compared to the Q4-22 futures**

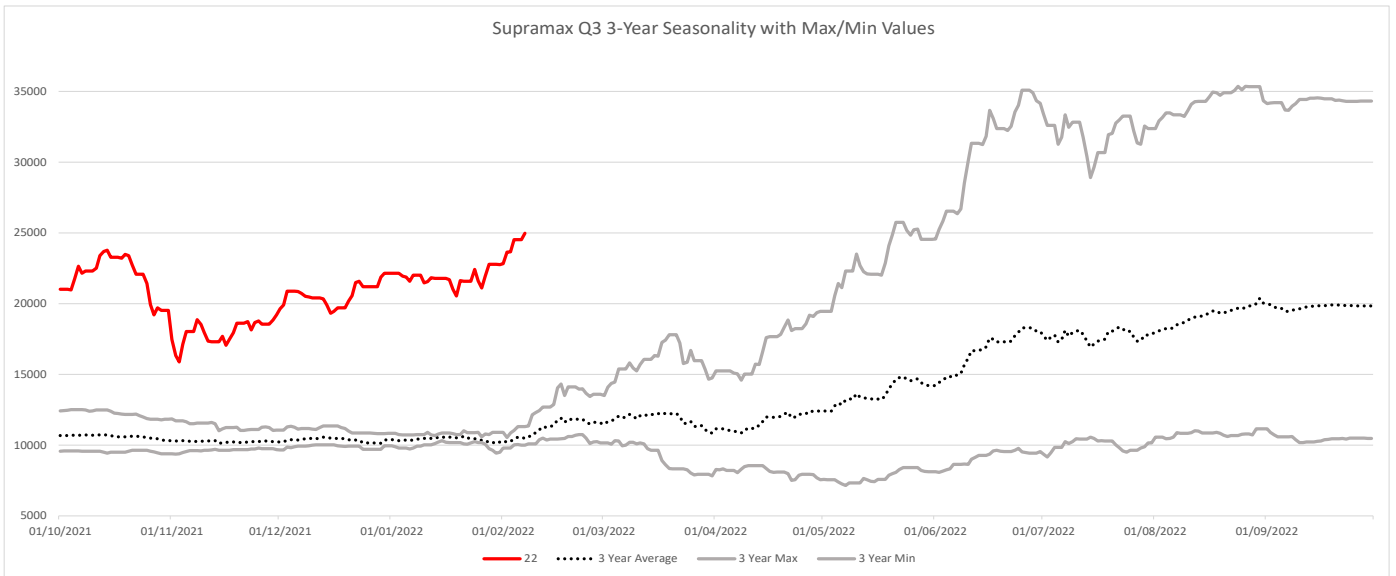
## Q2-22 v's Q3-22



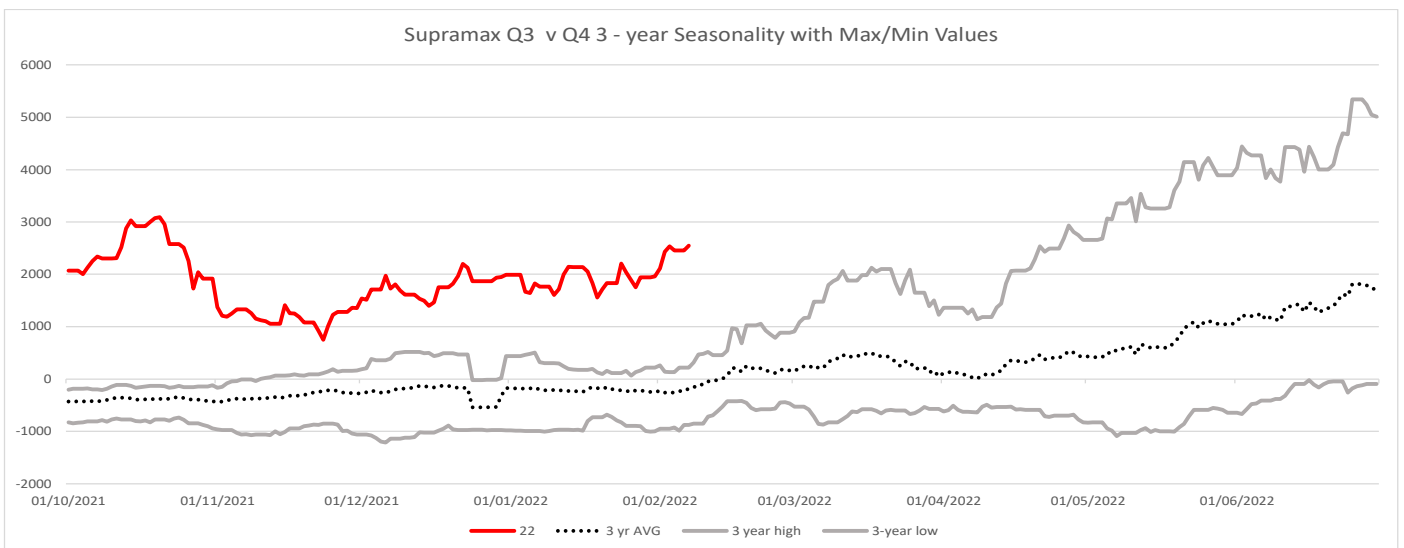

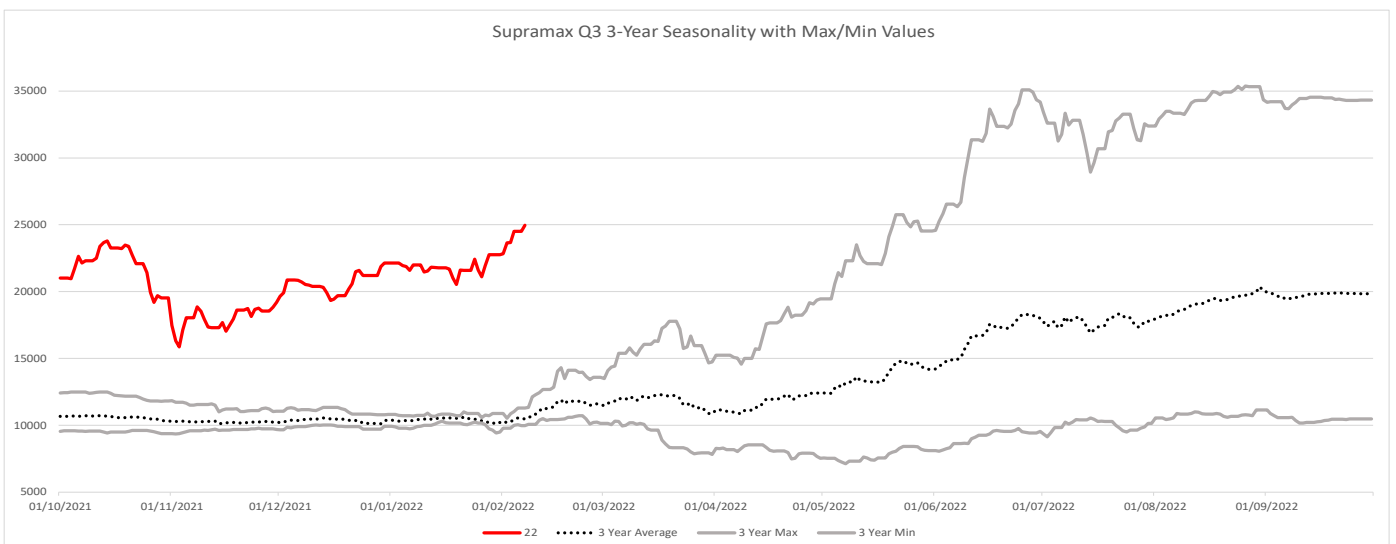

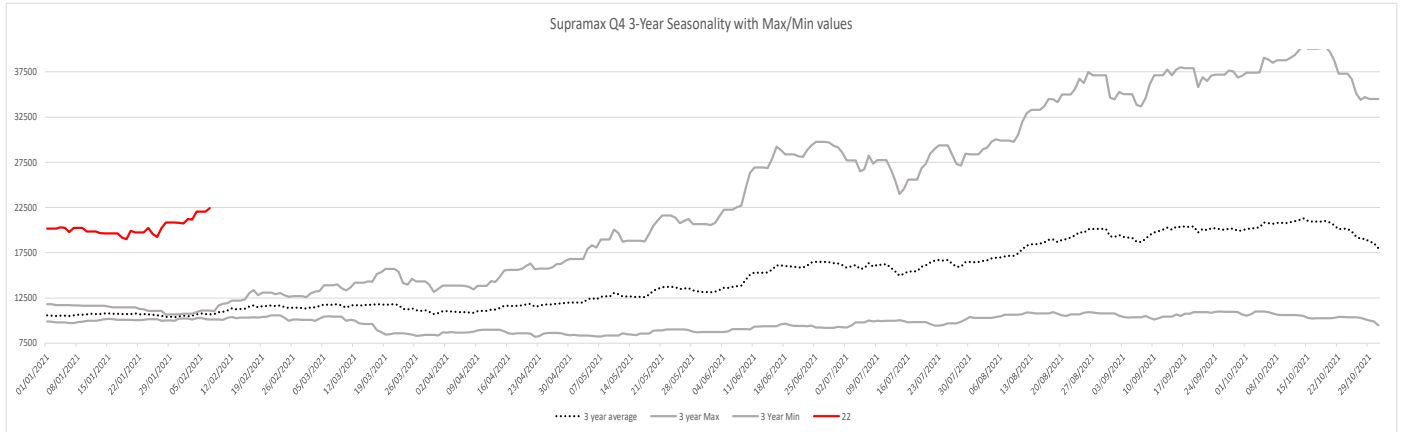
# Q3-22 v's Q4-22
