

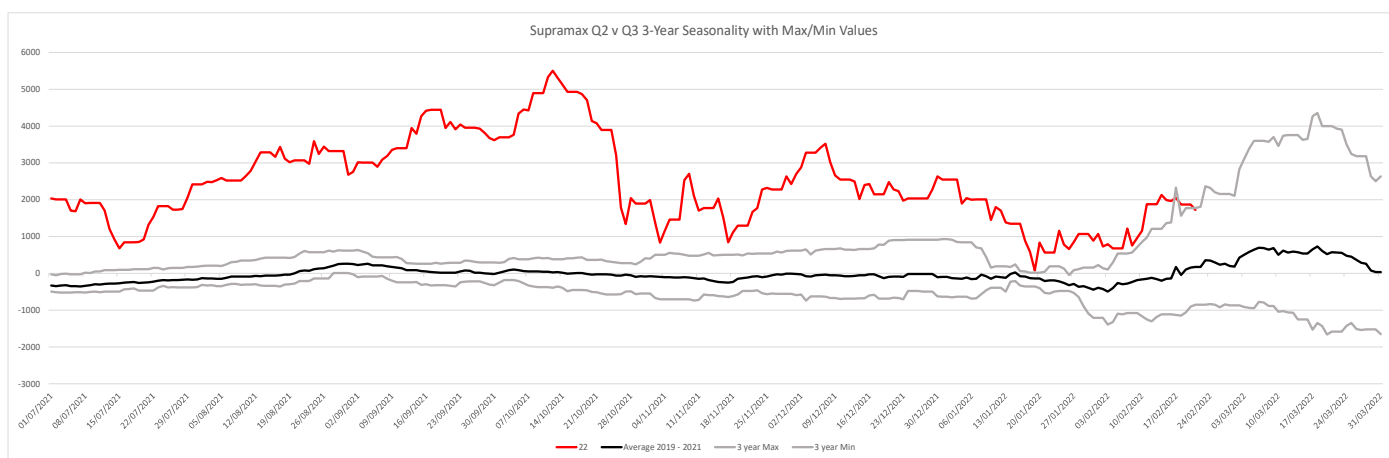

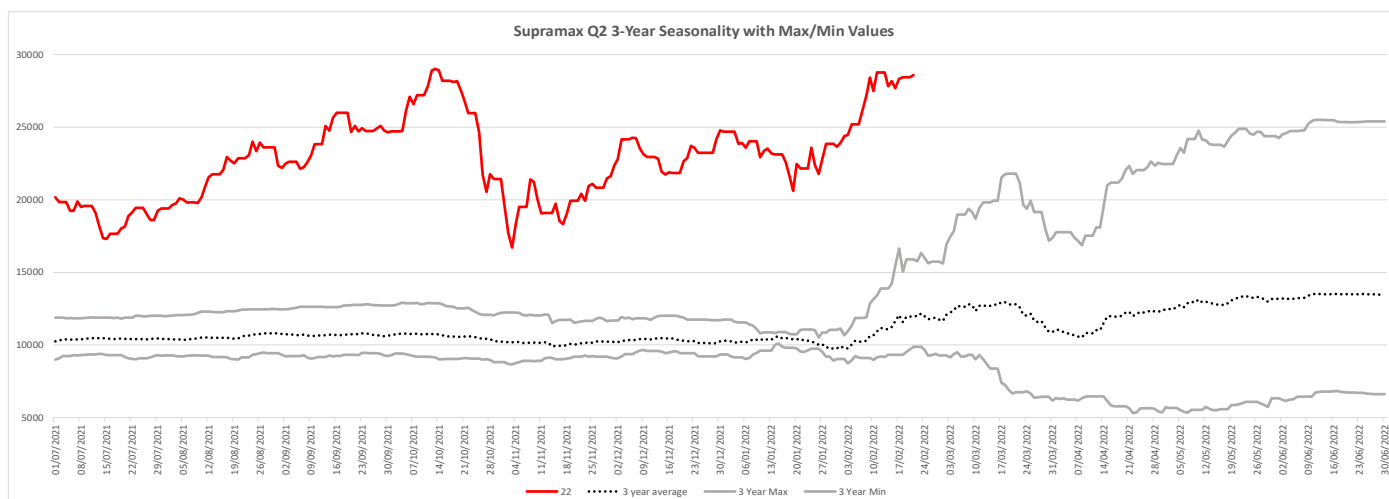

- Q2-22 v's Q3-22 Seasonality spread
- On the close of business on the 21/02/22 the Q2 v Q3 futures spread is currently trading USD 1,544 above the 3 year Average value
- On the close of business on the 21/02/22 the Q2-22 futures are USD 16,565 above their 3 year Average value
- On the close of business on the 21/02/22 the Q3-22 futures are USD 15,021 above their 3 year Average value
- **Verdict – The Q2-22 futures are overperforming compared to the Q3-22 futures**
- Q3-22 v's Q4-22 Seasonality Spread
- On the close of business on the 21/02/22 the Q3 v Q4 futures spread is currently trading USD 1,703 above the 3 year Average value
- On the close of business on the 21/02/22 the Q3-22 futures are USD 15,021 above their 3 year Average value
- On the close of business on the 21/02/22 the Q4-22 futures are USD 13,208 above their 3 year Average value
- **Verdict – The Q3-22 futures are overperforming compared to the Q4-22 futures**

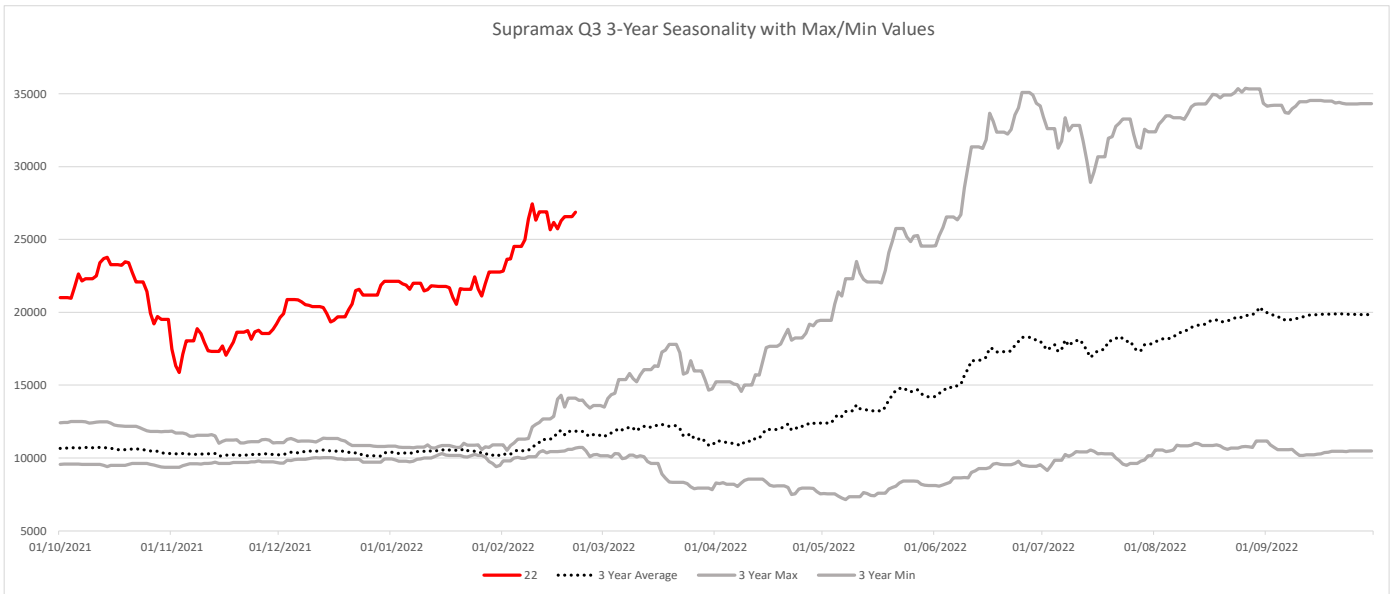
Q2-22 v's Q3-22



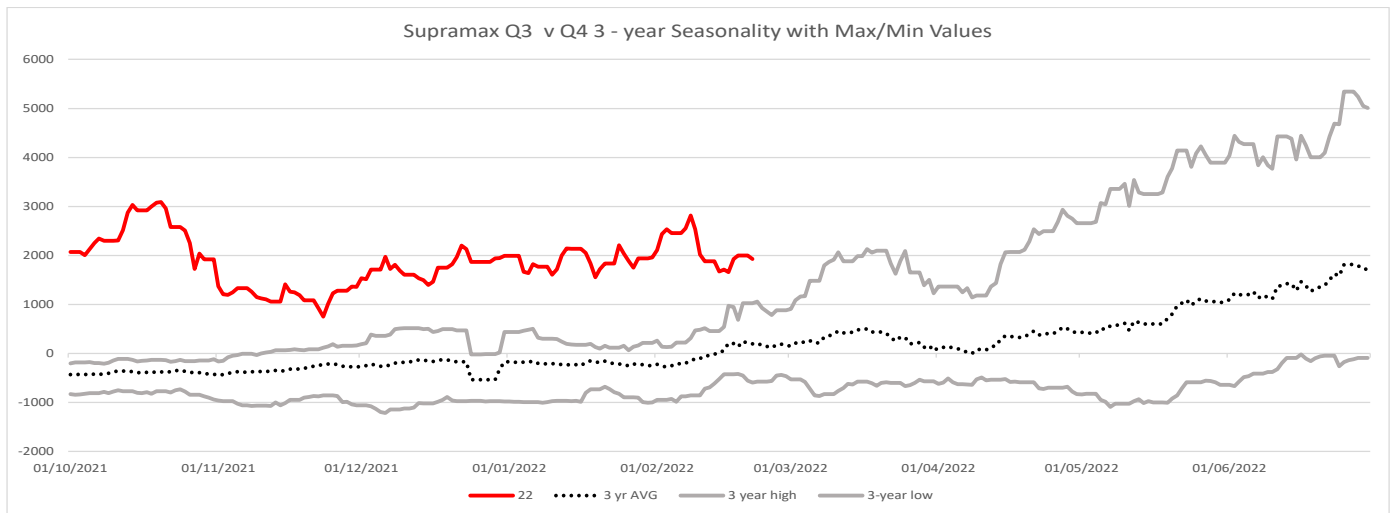

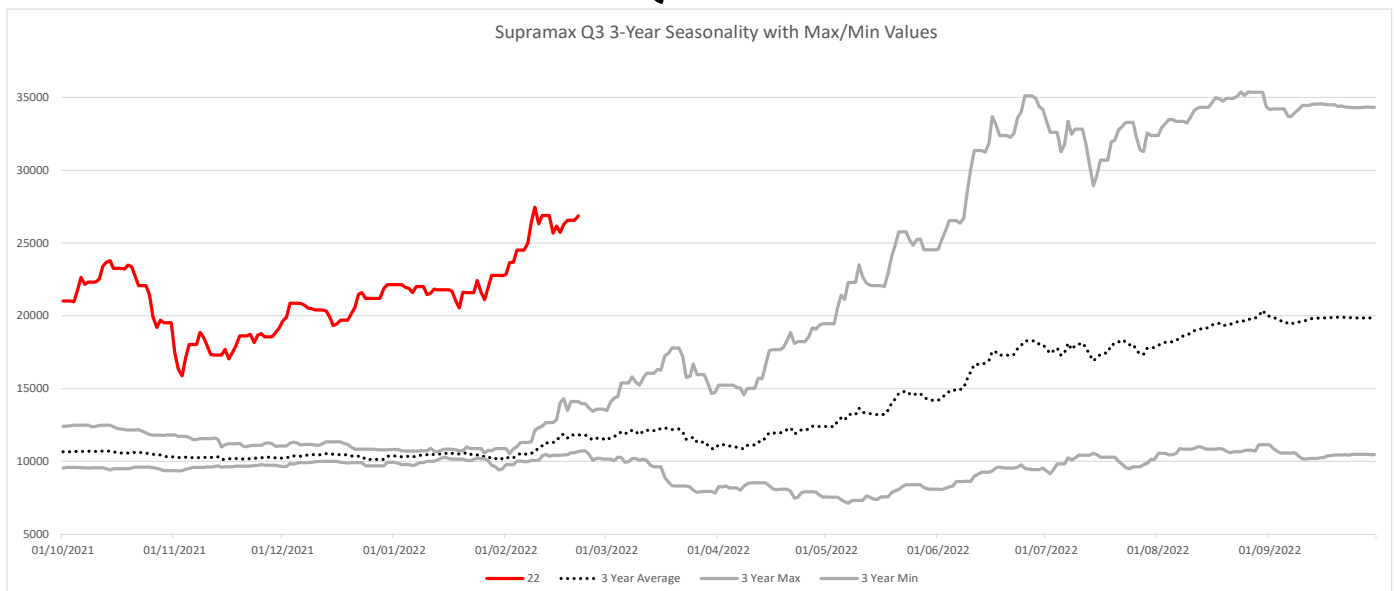

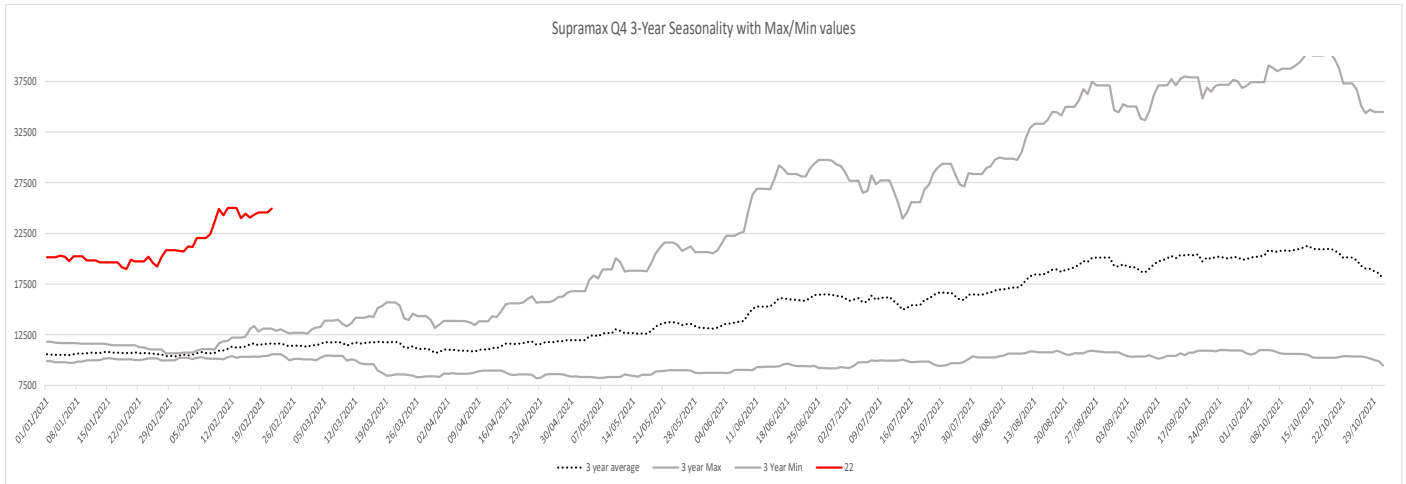
Q3-22 v's Q4-22
