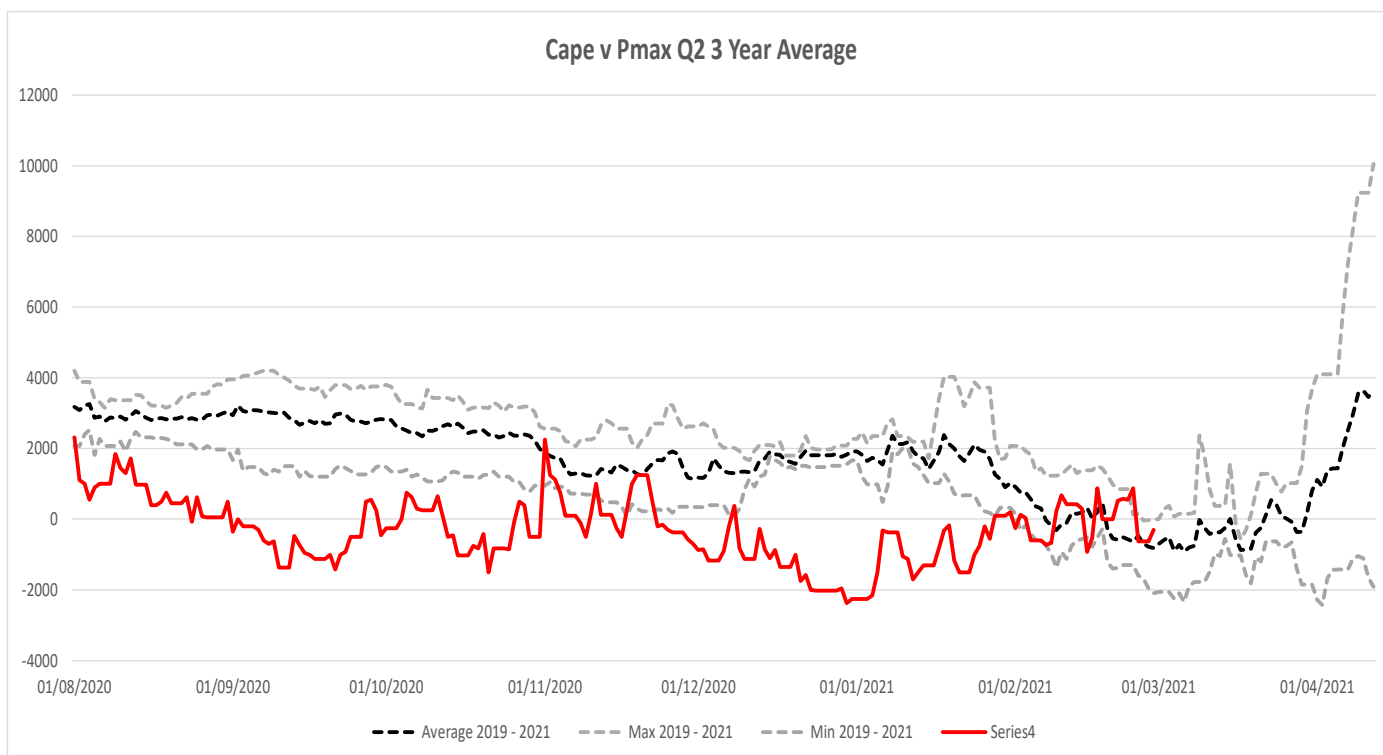


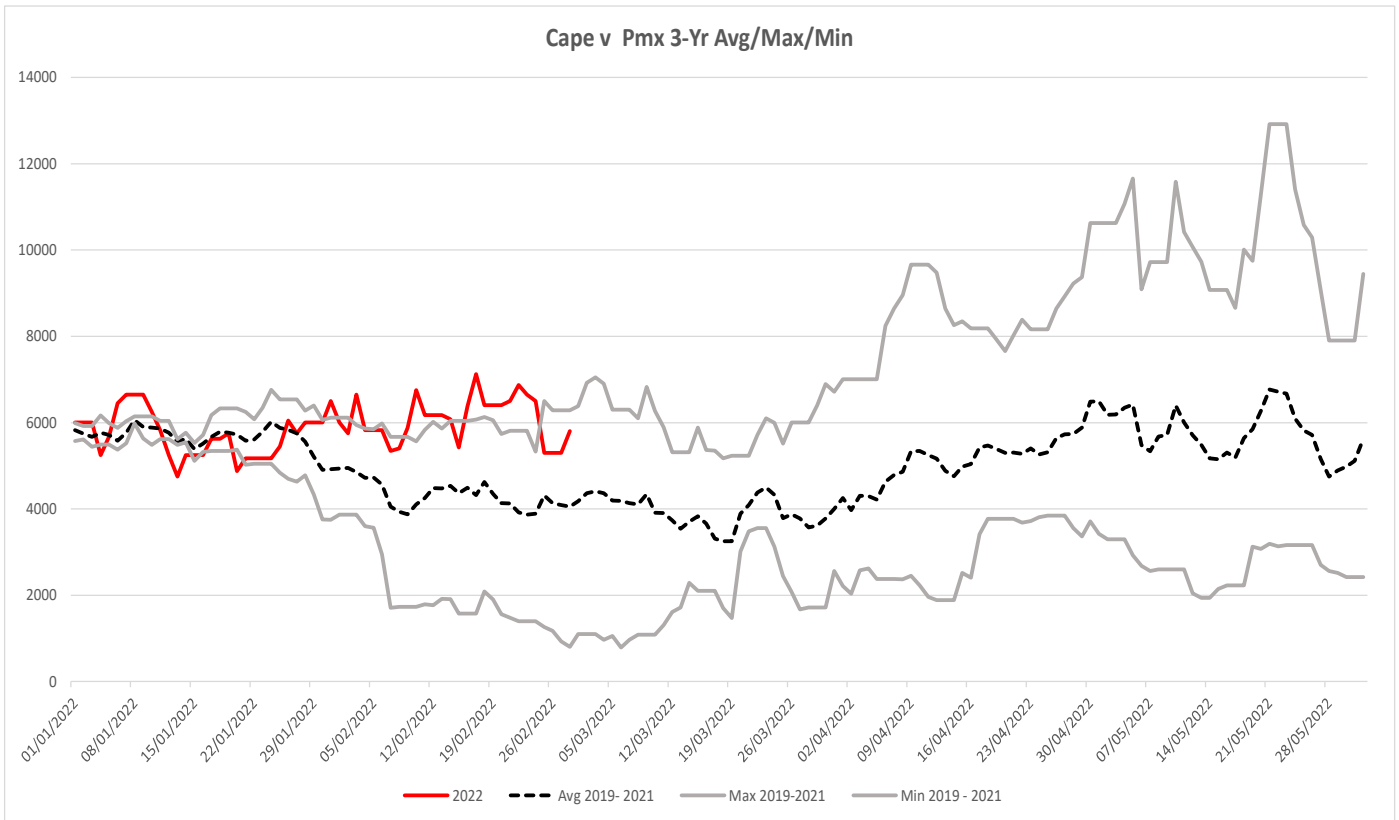

- **Q2-22 Seasonality spread** - On the close of business on the 28/02/22 the Q2 futures spread is currently trading USD 514 above the 3 year Average value. **Average seasonality values are flat.**
- **Q3-22 Seasonality spread** - On the close of business on the 28/02/22 the Q3 futures spread is currently trading USD 1,748 above the 3 year Average value. **Average seasonality values are flat to slightly lower.**
- **Q4-22 Seasonality spread** - On the close of business on the 28/02/22 the Q4 futures spread is currently trading USD 539 below the 3 year Average value. **Average seasonality values lean to the buy-side.**
- **Cal-23 Seasonality spread** - On the close of business on the 28/02/22 the Cal-23 futures spread is currently trading USD 462 below the 3 year Average value. **Average seasonality values lean to the buy-side.**

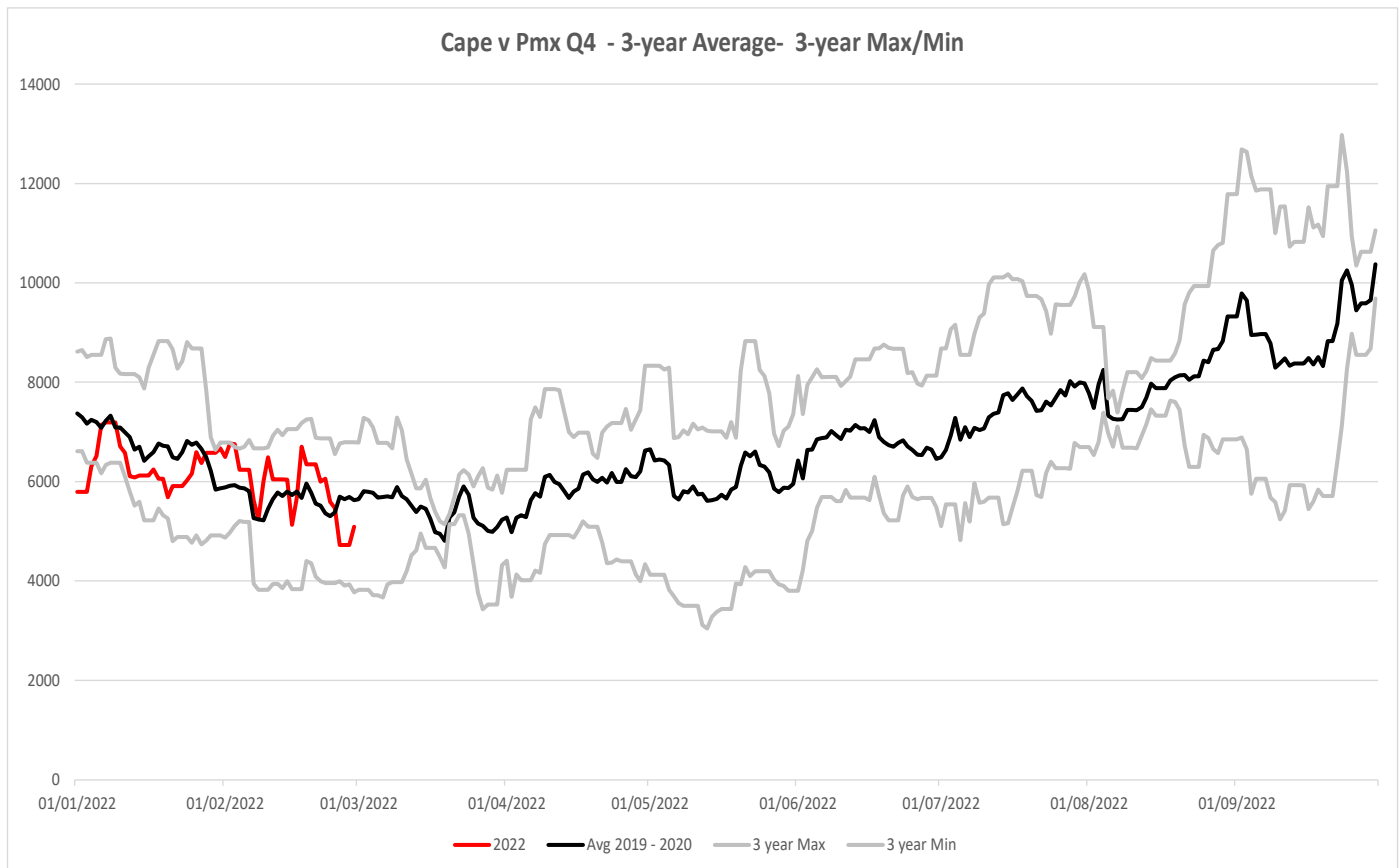

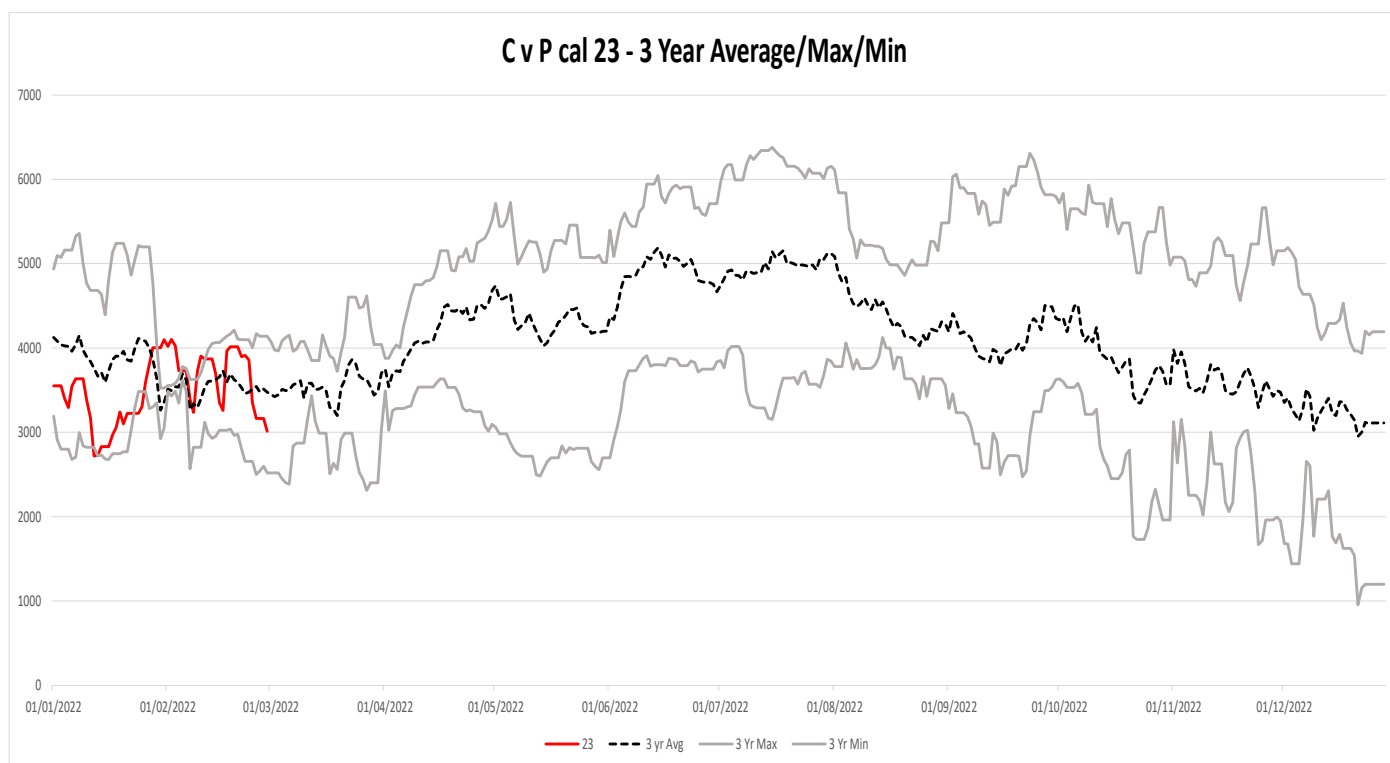
