


London Iron Ore Market Report



Iron ore futures continued to show resilience in the T+1 session, at one point breaking through \$162.50. Opening firm, prices jumped from \$158.35 to \$160.75 shortly off the open. Prices continued to rally thereafter, though trading was highly gappy, with prices moving by up to a dollar at a time. Mar/Apr was seen trading in significant clips of between 10-45Kt, mostly at -\$4.00, with Q2/Q3 seen trading in size at \$2.90 in 60Kt/m. Less interest on outrights relatively speaking, though Apr was seen trading at \$162.25 in 25KT.
