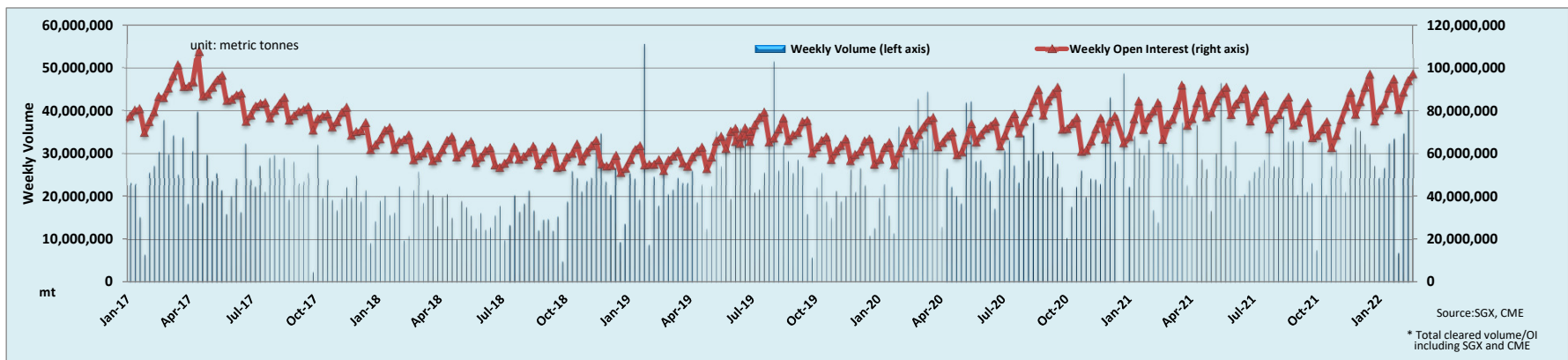
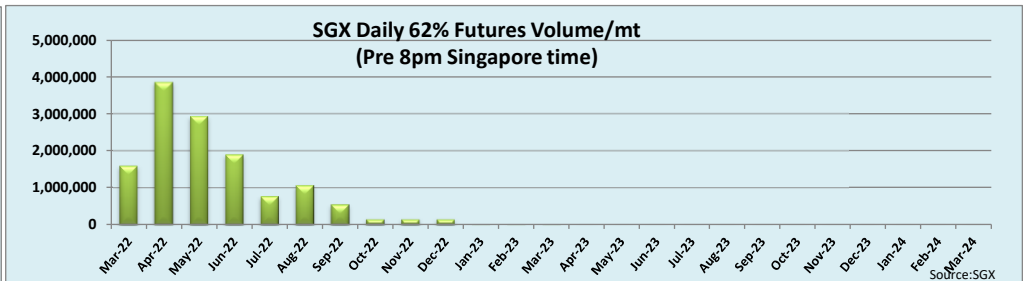
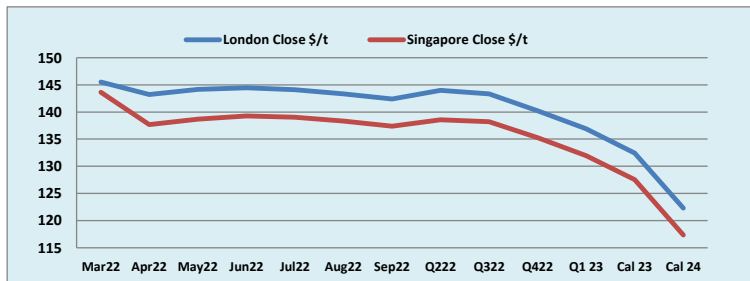
Offers were exceedingly scarce in the T+1 session, with buying interest seen in good sized clips across May/XXX spreads but lacking counters. Iron ore futures rallied considerably, wiping out a large portion of losses seen earlier in the day, gaining steadily from \$137.75 to \$143.00 over the course of the two hours. Closing out at \$143.20, iron ore futures closed just \$1.65 down on the day.
