



Focus was concentrated on the spread front months with APR/JUN, JUN/JUL and APR/JUL all finding counters and the first finding liquidity at -0.70 and 0.30 respectively in smaller clips. On the outrights Q4 found liquidity trading twice in clips of 5kt, whilst May also saw trading several times in clips of ten in rapid succession. Prices rallied to \$154.00 post close.
