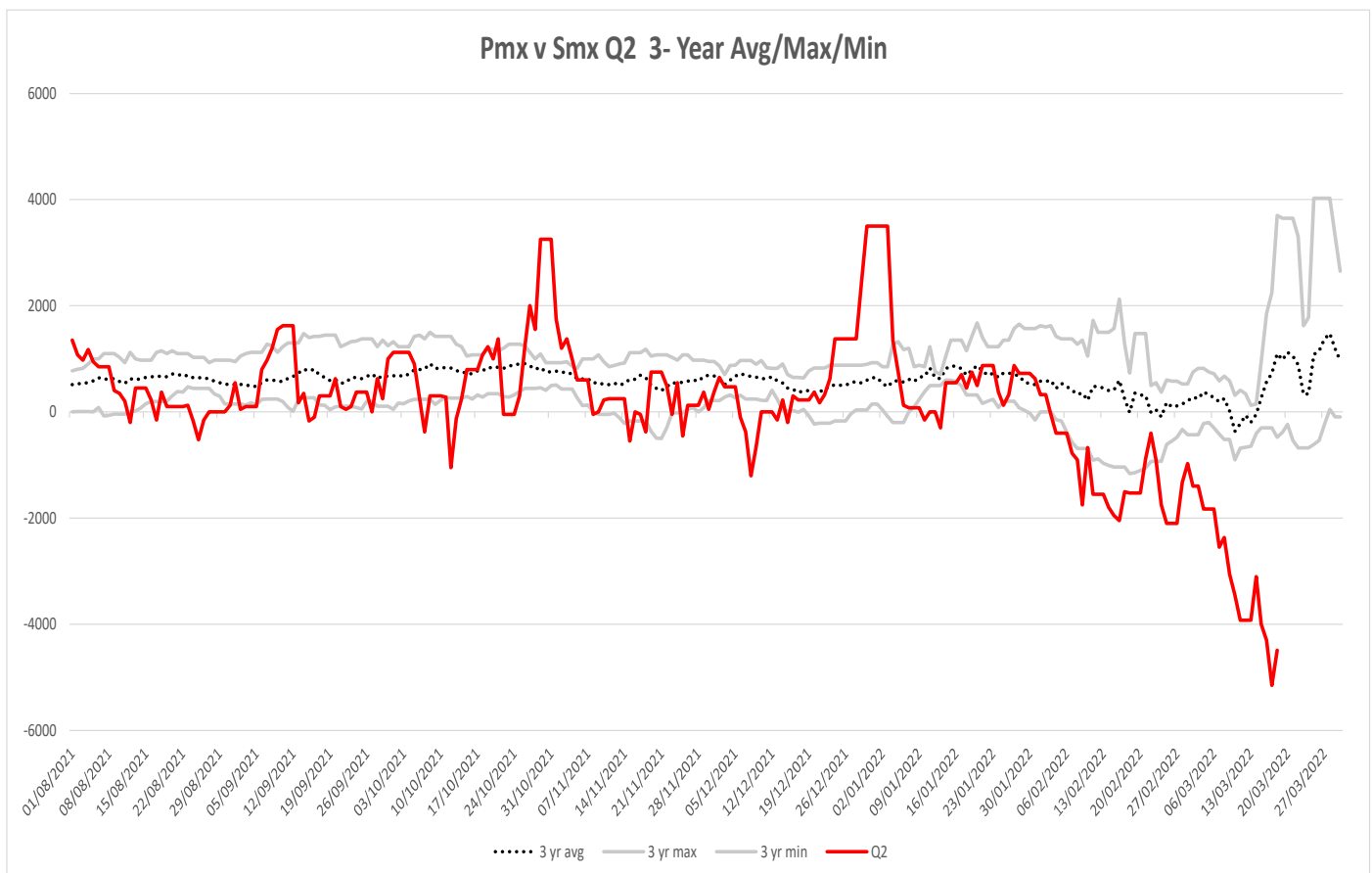


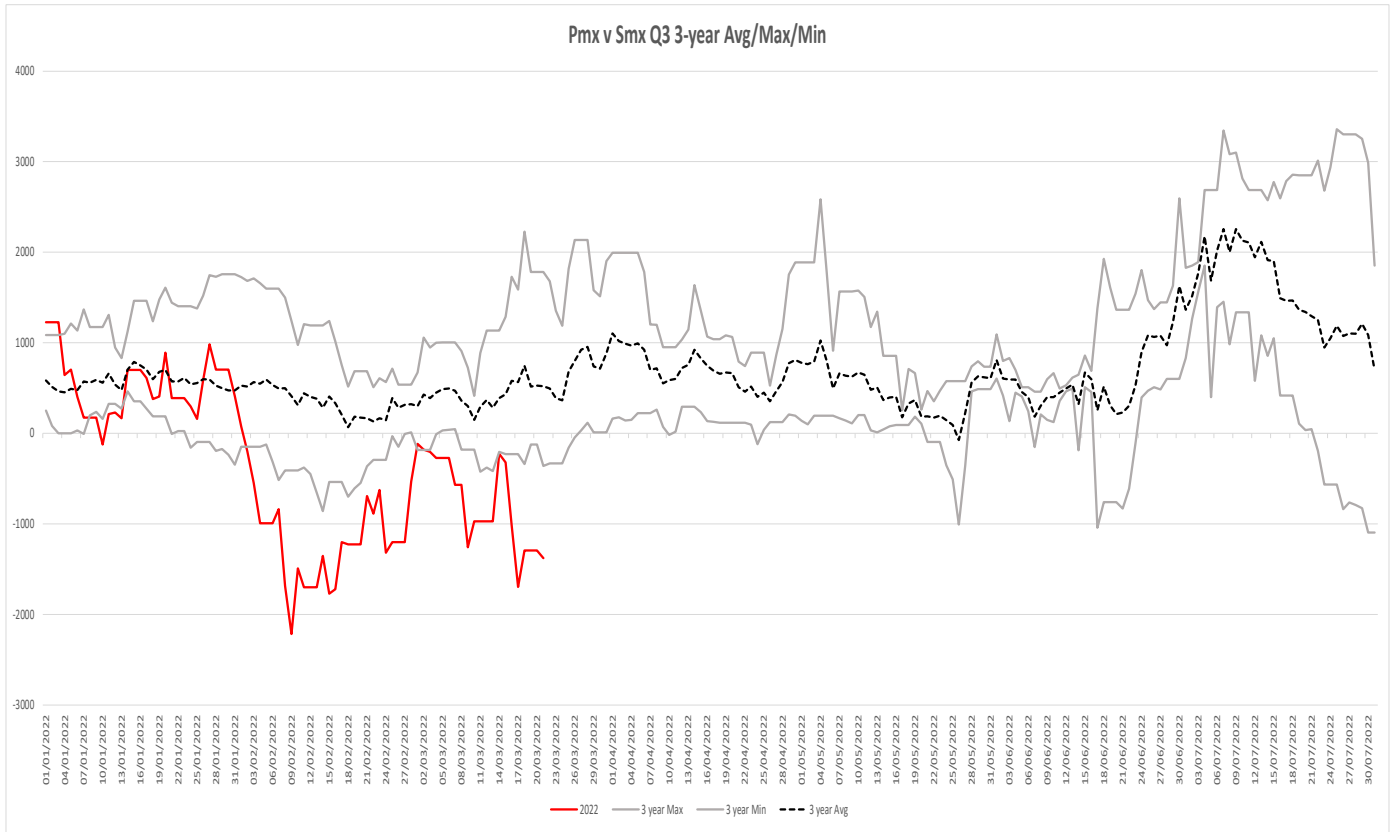

- Q2-22 Seasonality spread - On the close of business on the 21/03/22 the Q2 futures spread is currently trading USD 5,876 below the 3 year Average value. **Price is significantly below the 3 year average, seasonality values lean to the buy-side.**
- Q3-22 Seasonality spread - On the close of business on the 21/03/22 the Q3 futures spread is currently trading USD 1,902 below the 3 year Average value. **Average seasonality values lean to the buy-side.**
- Q4-22 Seasonality spread - On the close of business on the 21/03/22 the Q4 futures spread is currently trading USD 761 below the 3 year Average value. **Average seasonality values lean to the buy-side.**
- Cal-23 Seasonality spread - On the close of business on the 21/03/22 the Cal-23 futures spread is currently trading USD 104 below the 3 year Average value. **Average seasonality values are flat.**

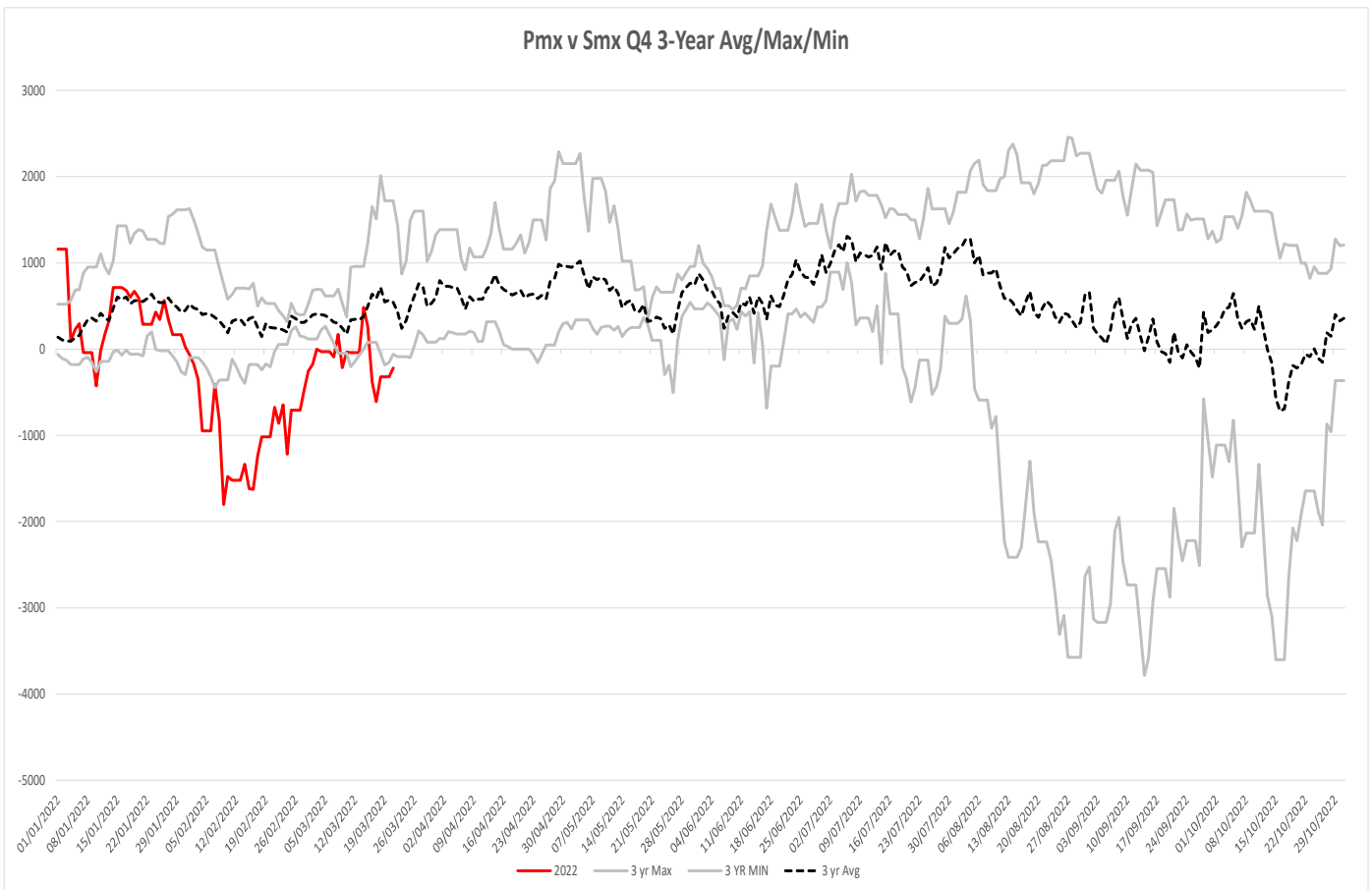

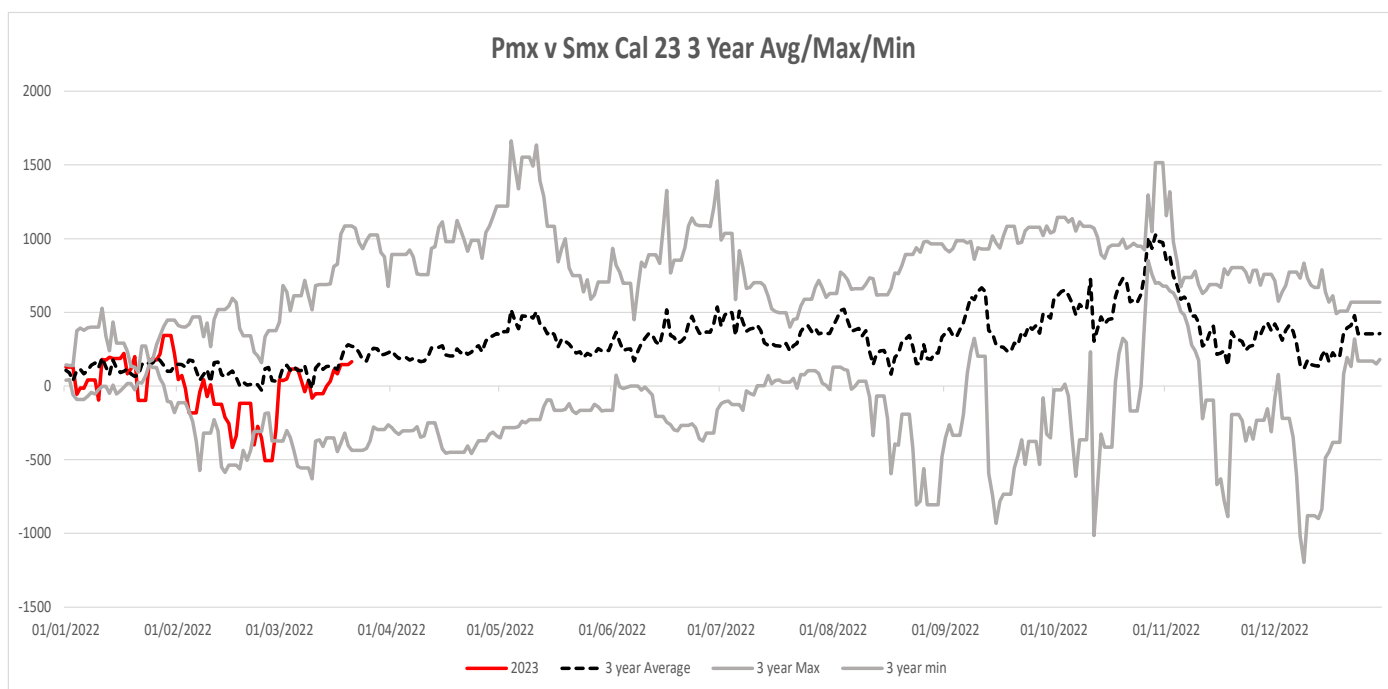
